Re: Approval of Renewal Cardroom Business License with Condition(s)

Dear Ms. Gallo:

On April 18, 2024, the California Gambling Control Commission (Commission) approved Bruce's Bar and Casino's application for renewal Cardroom Business license with the following condition(s).

1. *Prior to the opening for business, the Cardroom Business Licensee, shall provide to the Bureau of Gambling Control:*
 - A. *A current and fully completed Business Entity: Supplemental Information, CGCC-CH2-06 (Rev. 12/21), or its most current successor form, which includes the new address of the gambling establishment;*
 - B. *Cardroom Business Licensee must comply with applicable relocation requirements pursuant to California Code of Regulations, Title 4, Division 18, Chapter 7, Article 1, Section 12364;*
 - C. *A current and valid business license issued by the City of Blythe for the gambling establishment;*
 - D. *A current reviewed and approved Safety and Security Plan, as required by California Code of Regulations, title 4, sections 12370 and 12372;*
 - E. *A current Emergency and Evacuation Plan, as required by California Code of Regulations, title 4, section 12370, that has been approved by the responsible local authority;*
 - F. *A current lease for the gambling establishment's premises, if applicable; and*
 - G. *A current and complete Chart of Accounts, as required by California Code of Regulations, title 4, section 12312*
2. *The Owner-Licensee may not open or offer controlled games until the Bureau of Gambling Control has inspected the cardroom and determined that the cardroom is in compliance with all pertinent regulatory standards.*
3. *Within 45 days of Commission approval, John Gallo must submit documentation that adequately supports that their ownership interest in the owner category licensee is their sole and separate property or their*

respective spouse, Sharon Gallo, must apply for and thereafter maintain an owner category license in connection with Bruce's Bar and Casino.

That decision was stayed for 30-days to provide you the opportunity to request an evidentiary hearing.

On April 24, 2024, the Commission received your assent to the conditions placed on your license; therefore, the Commission's decision to approve the License with the above condition(s) is now final. (Bus. & Prof. Code, § 19870, subd. (c).)

Condition Compliance

The discussion regarding the placement of the condition can be found in the meeting minutes and audio recording of the meeting on our website, www.cgcc.ca.gov, under the meetings tab and select your corresponding meeting date in the audio column.

As a reminder, it is ultimately the Owner-Licensee's responsibility to remain in compliance with any conditions placed on the license. The Commission does ***not*** send reminder notices for compliance with the condition(s). **Failure to comply with Commission conditions may result in consequences up to and including denial or revocation of licensure.**

License Certificate

Upon receipt of the items listed in the above conditions and upon securing a location in accordance with the applicable relocation requirements, a license certificate will be issued valid through **October 31, 2025**, with the condition(s) listed above.

An application to renew the Cardroom Business license will be due to the Bureau 120-days prior to the license expiration date. The Bureau will send a courtesy notification letter approximately 150-days prior to the license expiration. However, it is ultimately your responsibility to ensure the renewal applications are submitted timely.
