PARTIES

1. On October 17, 2016, Wayne J. Quint, Jr. (Complainant), solely in his official capacity as the Chief of the California Department of Justice, Bureau of Gambling Control (Bureau), caused to be filed an Accusation, in the above-referenced matter, against Irving Moskowitz, seeking the revocation of his state gambling license number GEOW-003292.


2. Earlier, the Bureau received a Certification of Death, state file number 2016092712, issued on June 20, 2016, stating that on June 16, 2016, Irving Moskowitz died.

WITHDRAWAL

3. Inasmuch as Irving Moskowitz is deceased, no further public-protection purpose would be served in this case by continuing to pursue the revocation of his state gambling license. Accordingly, solely as to Irving Moskowitz, state gambling license number GEOW-003292, the Accusation is withdrawn.

4. The Accusation is not withdrawn as to the remaining respondents in the above-referenced matter.
