**NOTICE OF MODIFICATIONS TO TEXT  
OF PROPOSED REGULATION:  
SECOND 15-DAY CHANGE**

**This notice was originally sent via email on September 30, 2004, but, through an oversight, the text of the 15-day change was not attached. The full text of the 15-day change has been posted on the Commission website since September 30. This notice is being re-sent today with the correct attachment; the public comment deadline is being extended from October 14 to October 21, 2004.**

Pursuant to the requirements of Government Code section 11346.8(c) and Title 1, California Code of Regulations, section 44, the California Gambling Control Commission (“Commission”) is providing notice of changes made to proposed regulations concerning proposition players and gambling businesses.

A public hearing was held on August 5, 2004, to provide a forum for public input and recommendations. The first 15-day change proposal was circulated for public comment on August 25, 2004. The enclosed draft of the second 15-day change contains additional changes to the text as a result of both public comments and further review by Commission and Division staff.

There have been three series of changes to the text of these regulations. The first series of changes (in the text originally proposed for permanent adoption) were shown in strikeout/underline style. The second series of changes were shown in the first 15-day change in double strikeout/double

underline. The third series of changes appears in the document that accompanies this notice: the second 15-day change. In this third series of changes, additions are shown *in italics*, deletions are shown in a box. Any regulation text enclosed in a box is proposed for deletion.

As was the case with the emergency regulations currently in effect, a number of Commission and Division forms are incorporated by reference into the permanent regulations. These forms are posted on the Commission website under the second 15-day change. For further information on these forms, please contact Pam Ramsay, Legal Secretary, at (916) 263-0459.

If you have any comments concerning the changes proposed in the second 15-day change, please submit them in writing between Thursday, September 30 and Thursday, October 21, 2004.
