NOTICE IS HEREBY GIVEN that the Commission has proposed modifications to the proposed regulatory action entitled: *Minimum Internal Control Standards (MICS) for Gambling Establishments: Gambling Floor Operations and House Rules*; CGCC-GCA-2011-02-R. A formal 45-day public comment period was held from August 5, 2011 through September 19, 2011, pursuant to the Notice of Proposed Regulatory Action duly published in the *California Regulatory Notice Register* on August 5, 2011 (Z-2011-0726-02, Register 2011, No. 31-Z, 08/05/2011). The proposed regulations were also considered by the Commission in a rulemaking hearing held on March 8, 2012.

Modifications are being proposed to the text of Sections 12360, 12391 and 12392 in Title 4 of the California Code of Regulations. The proposed modifications include a number of options which the Commission will consider in the final adoption of these regulations.


