

**NOTICE OF AVAILABILITY OF
MODIFIED TEXT OF DISAPPROVED REGULATIONS
15-Day Written Comment Period**

(Pursuant to Government Code section 11346.8(c), and Title 1, California Code of Regulations, Section 44)

NOTICE IS HEREBY GIVEN that the California Gambling Control Commission (Commission) has proposed modifications to the proposed regulatory action entitled: *Minimum Internal Control Standards (MICS) for Gambling Establishments: Gambling Floor Operations and House Rules*; CGCC-GCA-2011-02-R. A formal 45-day public comment period was held from August 5, 2011 through September 19, 2011, pursuant to the Notice of Proposed Regulatory Action duly published in the *California Regulatory Notice Register* on August 5, 2011 (Z-2011-0726-02, Register 2011, No. 31-Z, 08/05/2011). The proposed regulations were also considered by the Commission in a rulemaking hearing held on March 8, 2012. Modified text was previously published April 30, 2012 (1st 15-day change), and made available for public comment until May 15, 2012, and again May 30, 2012 (2nd 15-day change), and made available for public comment until June 14, 2012. The Commission approved the final regulations on July 11, 2012, and the Rulemaking File was submitted to the Office of Administrative Law (OAL) on July 31, 2012 (OAL File No. 2012-0731-02 S).

On September 12, 2012, the OAL granted a partial approval of this Rulemaking File and disapproved paragraph (2) of subsection (a) of Section 12391 of the proposed regulations. The disapproval was based on a determination that the language of that paragraph failed to meet the Clarity standard of Government Code section 11349.1.

Modifications are being made in the text of proposed Section 12391(a)(2) to address the lack of clarity cited by OAL in their disapproval. A copy of the modified text is enclosed. The specific language of the originally proposed regulations, the previously noticed modified text and this latest modified text are also available on the Commission's Web site, at www.cgcc.ca.gov, under "Laws and Regulations/Recently Approved Regulations."
