



ADVISORY NOTICE

APPROVAL OF UPDATED FORMS

(CGCC-GCA-2017-01-N)

On July 5, 2017, the Bureau of Gambling Control (Bureau) headquarters in Sacramento moved to a new location with a new telephone number. Information on the old location and the new location is listed below. As a result of this move, 30 application forms used by the California Gambling Control Commission (Commission) and the Bureau for the regulation and enforcement of controlled gambling have been updated to include the new address and telephone number and to make other conforming changes. On September 7, 2017, the Office of Administrative (OAL) approved these non-substantive changes without regulatory effect. This package was filed with the Secretary of State and become effective on this date.
