To: California Cardroom Industry Members

Re: Update on Governor Directed Cardroom Closures within Specified Counties

As provided in the [Commission's correspondence released on July 1, 2020](#), Governor Gavin Newsom and the California Department of Public Health released [guidance](#) directing counties that have been on the [County Monitoring List](#) for three consecutive days or more to close indoor operations for certain sectors which promote the mixing of populations beyond households and make adherence to physical distancing and wearing face coverings difficult. The directive includes the closing of cardrooms within the specified counties. Today, Governor Newsom added three counties to the impact counties list, which are listed in bold below. As of today, the following counties are impacted: Colusa; Contra Costa; Fresno; Glenn; Imperial; Kern; Kings; Los Angeles; Madera; Marin; Merced; Monterey; **Napa**; Orange; Riverside; Sacramento; **San Benito**; San Diego; San Bernardino; San Joaquin; Santa Barbara; Santa Clara; Solano; Stanislaus; Tulare; Ventura; and, **Yolo**. All cardrooms identified within the specified counties should be closed. Those cardrooms within the counties identified on this list today are required to close operations immediately, today.

Please see the attached listing which identifies those cardrooms impacted by the Governor's directive to close.

At this time, the directive applies for a minimum of three weeks and is subject to an extension based on epidemiologic indicators.

Cardrooms who were required to close, if you haven't done so already, please notify the Bureau of Gambling Control via email at gamblingcontrol@doj.ca.gov as soon as possible verifying the date of closure.
