To: California Cardroom Industry Members

Re: Governor Directed Cardroom Closures within Specified Counties

Today, Governor Gavin Newsom and the California Department of Public Health released [guidance](#) directing counties that have been on the [County Monitoring List](#) for three consecutive days or more to close indoor operations for certain sectors which promote the mixing of populations beyond households and make adherence to physical distancing and wearing face coverings difficult. The directive includes the closing of cardrooms within the specified counties. As of today, the following 19 counties are impacted: Contra Costa; Fresno; Glenn; Imperial; Kern; Kings; Los Angeles; Merced; Orange; Riverside; Sacramento; San Bernardino; San Joaquin; Santa Barbara; Santa Clara; Solano; Stanislaus; Tulare; and Ventura. Please see the attached listing which identifies those cardrooms impacted by the directive.

**Those cardrooms within the specified 19 counties must close as soon as possible today in a manner that ensures the safety of customers and employees.**

At this time, the directive applies for a minimum of three weeks and is subject to an extension based on epidemiologic indicators.

Cardrooms who are required to close, please notify the Bureau of Gambling Control via email at [gamblingcontrol@doj.ca.gov](mailto:gamblingcontrol@doj.ca.gov) as soon as possible once your establishment has closed to the public.
