APPOINTMENT

Pursuant to Business & Professions Code Section 19817, there shall be ten (10) members of the Gaming Policy Advisory Committee (GPAC), who are appointed directly by the California Gambling Control Commission (Commission).

TERM

Category B-H GPAC Members may serve two (2) consecutive terms of up to three (3) years each on a respective Category seat. A Category A GPAC Member may serve a term of three years per each appointment without restriction on consecutive terms.

Category B-H GPAC Members may not serve more than seven consecutive years across all categories unless the following exception(s) apply:

- 1) If there is an expired seat with no appointed candidate, and the Commission is actively recruiting to fill the vacancy, the incumbent member could serve up to one additional year at the request of the Executive Director; and
- 2) If after one additional year provided under 1) no appointment has been made to fill the expired seat, and the Commission continues to actively recruit, further exceptions to the term limits for the expired seat can be approved by the Commission at a publically noticed meeting.

Category B-H GPAC Members currently active and appointed to the 2022 GPAC will automatically convert to a three-year term with initial expiration dates as follows and maintaining an expiration date of every three years thereafter:

REPRESENTATION

Members of GPAC shall be appointed under the following representative categories:

PUBLIC MEMBERS (5): Categories A, B, F, G, H: LICENSEE MEMBERS (5): Categories C, D, E

- A: An employee from the Bureau of Gambling Control, Department of Justice (1 seat)
- B: An agency or nonprofit concerned with problem gambling and/or gambling addiction (1 seat)
- C: A licensee, agent, or employee from a Third Party Provider of Proposition Player Services (1 seat)
- D: A licensee, agent, or employee from an actively licensed cardroom with 25 licensed tables or more (2 seats)
- E: A licensee, agent, or employee from an actively licensed cardroom with less than 25 licensed

tables in operation (2 seats)

F: An applicant affiliated with local law enforcement from a local government where an approved ordinance allows legalized gaming (1 seat)

G: A professional with accounting or business background and not currently affiliated with any California legalized gambling entity (1 seat)

H: General member at large not currently affiliated with any California legalized gambling entity (1 seat)

Category B-H Members of GPAC appointed under these categories shall demonstrate and provide evidence of competency during the selection process and *prior* to their appointment or reappointment.

If appointed, all GPAC Members must maintain eligibility throughout their term(s) served. A "licensee, agent or employee" means a person with an owner's or key employee license associated with a cardroom or Third Party Provider of Proposition Player Services with an active license, an endorsee on an owner's gambling license for an active licensee, or a designated agent, attorney or employee of the licensee.

SELECTION

Applicants for Category B-H who wish to be considered for recommendation to the GPAC shall complete an "Application for Appointment to the Gaming Policy Advisory Committee (GPAC)" and submit it to the Executive Director of the Commission. After being properly submitted, if a vacancy exists in which the applicant is eligible, the applicant will be interviewed by a selection panel which shall include the Executive Director and two (2) sitting members of the GPAC. Upon completion of these interview panels, the Executive Director shall make a written recommendation for appointment of those individuals qualified to the Commissioners for consideration at a publicly noticed meeting.

GPAC members that have reached their term limits in their respective seats and wish to continue their service with the GPAC may apply for vacant or upcoming vacancies in category seats in which they have or possess the qualifications or personal experience set forth by the Commission.

A Category A GPAC Member is exempt from the application and interview process; however, the Commission must receive a signed letter from the Director of the Department of Justice's Bureau of Gambling Control (Bureau) designating the incumbent as the Bureau Director's selection for recommendation of appointment by the Commission. The Bureau's designation letter must be received prior to December 1st of the year the Category A seat term is set to expire or to replace or fill a vacant Category A GPAC Member seat.

RESIGNATION / REMOVAL

The Commission may remove members of the Committee at any time, for any reason.

The Executive Director or an active member of the GPAC may place or request to place on a GPAC public meeting agenda an agenda item for the discussion and vote to remove a GPAC member for any of the following causes:

- Three or more absences at a GPAC meeting during a calendar year;
- Inappropriate or unprofessional representation of the Commission, Bureau, or GPAC;
- Member is no longer eligible to hold the GPAC category seat they were appointed to; or,
- Consistent lack of participation at meetings and/or sub-committee projects.

If the six or more votes are received by the GPAC, the item of removal of the GPAC member will go before the Commissioners for consideration at a future Commission Licensing Meeting.

Committee Members may resign from the Committee by emailing a statement from the email address they listed on their GPAC application, or from another personal or professional email account which was previously provided to the Executive Director of the Commission. The statement should expressly

indicate that they are resigning, the reason for resigning, and include the date on which the resignation will be effective.

Following the removal or resignation of a Committee member, notification of all current vacancy(ies) on the Committee, including detail of the category(ies) in which the vacancies exist, will be sent to the Commission's mailing list, and posted on the Commission's website. Notifications will continue to be sent on a periodic basis until the Commission selects a new member for the Committee.

The newly selected member will complete the term of the Committee Member who they replaced. Following completion of that term, they may be selected to serve up to two more terms consecutively. For purposes of calculating the Committee Member's term, any time they served in replacing the prior Committee Member beyond one year will not be considered for purposes of term limits discussed above.

RENEWAL

A notification of the expiring terms of GPAC Committee Members will be sent to the Commission's mailing list, and posted on the Commission's website, not less than three (3) months prior to the expiration dates.

Members of the Committee in good standing, who want to remain on the Committee for another term, meet the requirements of the category they were appointed to and all other requirements of the GPAC, and who run unopposed in their category, may be recommended to the Commission with a consensus from the GPAC without a formal interview process.
