RE: <u>Draft Regulations Concerning "Advertising"</u>

The California Gambling Control Commission (Commission) commenced the formal rulemaking process for regulations concerning "Advertising" on December 30, 2022, via the publication of the notice of the proposed action in the California Regulatory Notice Register. Pursuant to Government Code section 11346.4, subdivision (b), the effective period of that notice of proposed action expires on December 29, 2023.

The proposed action noticed on December 30, 2022, will not be completed and transmitted to the Office of Administrative Law within the one-year period. As a result, the Commission will need to issue a new notice for this proposed action in the future.

Prior to doing so, the Commission will hold a regulations workshop for consideration of approval to commence the formal rulemaking process anew for regulations concerning "Advertising" in early 2024. In advance of that workshop, Commission staff will make available summaries and proposed responses to written comments received during the 45-day written comment period of the previous proposed action, as well as any proposed modifications to the previous version of the regulation text noticed on December 30, 2022. Details of the forthcoming regulations workshop will be provided in the near future.
