## Report on the Status of all Uncompleted Rulemaking Described on Previous Calendars:

**Advertising** – Noticed December 30, 2022; deadline for filing with OAL pursuant to Government Code section 11346.4, subdivision (b), has passed. Notice of incomplete rulemaking sent to stakeholders on December 20, 2023. The California Gambling Control Commission (Commission) plans on holding a regulations workshop in early 2024 to deliberate on previous public comments and consider commencing the formal rulemaking process anew.

**Surveillance** – Noticed April 7, 2023; expected to be completed and filed with OAL in February 2024.

**Approval of Transactions** – Preliminary rulemaking activity continues; Commission staff is revising draft text based on comments in the December 2022 regulations workshop and a subsequent industry survey of affected transactions; Commission plans on holding the next regulations workshop in 2024.

**Marketing Groups** – See "Independent Promoters," above.

**Spousal Community Property** – Pursuant to Commission action on August 24, 2023 pertaining to "Spousal Licensing," the Commission is no longer pursuing this concept.

**Fee Modifications** – This concept will be three separate regulatory packages; see "Update to Annual Fees," "Annual Fee Modifications," and "Update to Direct Fees," above.

**Requirements for New Cardrooms** – The Commission is no longer pursuing this concept due to reinstatement of a cardroom moratorium pursuant to AB 341 (Chapter 8, Statutes of 2023, Ramos).

**Mandatory Denials – Temporary Licensure** – The Commission does not anticipate pursuing this concept in 2024.

**Outdoor Gaming** – The Commission does not anticipate pursuing this concept in 2024.

**Non-Licensed Employee Badge Requirements** – The Commission does not anticipate pursuing this concept in 2024.
