MINUTES OF APRIL 8, 2009 COMMISSION MEETING

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairman Dean Shelton called the meeting to order at 10:02 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken with Chairman Dean Shelton and Commissioners Stephanie Shimazu, and Alexandra Vuksich present.

3. Approval of Commission Meeting Minutes for: March 12, 2009

Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the meeting minutes for March 12, 2009.

- 4. <u>Applications for Renewal of State Gambling License Including All Associated Applicants and Endorsees (Pursuant to Business and Professions Code section 19876):</u>
 - A. The Bicycle Casino: The Bicycle Casino, L.P.

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the renewal application for the state gambling license for the period of May 1, 2009 through April 30, 2011, while removing the existing condition.

Commissioner Vuksich questioned the increase in the number of calls for service and requested that the Commission be provided with comparison data from one reporting period to the next.

Joy Harn, Attorney for The Bicycle Casino, indicated that they are very proactive regarding security; however, there was an increase in calls for service. She commented that the increase is representative of the Los Angeles area in this economy. Ms. Harn agreed to work with the Bureau of Gambling Control to provide the Commission with the requested comparison data.

Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

B. Comstock Card Room: Joseph and Monica Melech, Sole Proprietors

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the renewal state gambling license for the period of May 1, 2009, through April 30, 2011. Upon motion of Commissioner Shimazu, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

c. Gloria's Lounge and Casino: Gloria Gutierrez, Sole Proprietor

Deputy Director Tina Littleton indicated that staff recommended that the Commission extend the renewal state gambling license from May 1, 2009 through October 31, 2009 and continue with the following existing condition:

Chip account statements must be submitted quarterly.

Chris Davis Licensing Manager at Bureau of Gambling Control indicated that the audit staff reviewed the chip account and found it to be in order. Therefore, the Bureau recommended that the condition be removed.

Commissioner Vuksich requested clarification regarding the note on the property and how payment was made to Ray and Mary Philpot.

Deputy Director Littleton indicated that according to the report that Mr. and Mrs. Gutierrez and Ms. Rogers did receive a loan from Mr. and Mrs. Atkins to pay off the loan that was owed to the Philpots.

Chris Davis Licensing Manager at Bureau of Gambling Control concurred with Deputy Director Littleton.

Commissioner Vuksich asked if it was secured by the deed and if the Bureau had proper documents supporting that transaction such as a promissory note.

Chris Davis Licensing Manager at Bureau of Gambling Control indicated that she was unsure if they had evidence of that transaction.

Commission Shimazu indicated she was not clear if Ms. Rogers was equally responsible for the loan that Mr. and Mrs. Gutierrez appear to be using for purposes other than intended.

Chris Davis Licensing Manager at Bureau of Gambling Control indicated that when they do a renewal they don't do an in-depth financial analysis. They would have to get a supplemental application and collect more fees to do the research if that is what the Commission recommends.

Chairman Shelton indicated that the Bureau does not do an in-depth analysis on a renewal when there is no suspicion on their part to do so; but, if the Commission would like the research done then the Commission needs to give the Bureau time to complete it.

Chairman Shelton moved to approve the staff's recommendation to remove the existing condition and add the following two new conditions:

- 1. Applicant will submit a copy(s) of the promissory note (or loan agreement) reflecting the mortgage information involving the gambling establishment.
- 2. Applicant will submit to the Bureau all transactional documents that will clearly establish the business relationship between the applicant and all property owners.

The motion was seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes.

Deputy Director Tina Littleton indicated that the Bureau of Gambling Control recommended that the Commission approve the applications for key employee personal portable licenses as listed in Item 5 A - D. Commission staff has reviewed the Bureau's reports and concurs with their recommendations.

Chairman Shelton indicated he had concerns that Mr. Cilibrasi's financial status indicates a gambling problem.

Chairman Shelton moved to approve the recommendation by the Bureau of Gambling Control for the individuals in Items 5A, 5C and 5D. The motion was seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes.

Chairman Shelton wanted to know if Mr. Cilibrasi heard his concerns and if he thought the Commission should have any reason to be concerned.

Anthony Cilibrasi indicated there was no reason for the Commission to be concerned. His financial situation occurred when he was young. He further indicated that he currently has a payment plan and has settled most of his debt.

Chairman Shelton moved to approve the recommendation by the Bureau of Gambling Control for Item 5B Anthony Cilibrasi. The motion was seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes.

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the applicant's request to withdraw <u>without</u> prejudice. Upon motion of Commissioner Shimazu, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

Deputy Director Tina Littleton indicated that the Bureau of Gambling Control recommended that the Commission approve the applications to convert owner registrations to licenses for the applicant in Items 7 and 8. Commission staff has reviewed the Bureau's reports and concurs with their recommendations.

Discussion commenced regarding the lack of supporting documentation for the gifts, loans and investment returns ultimately ending with the Commissioners and the Chairman concurring to table items 7 and 8.

Deputy Director Tina Littleton indicated that the Bureau of Gambling Control recommended that the Commission approve the applications to convert player registrations to licenses for the applicants in Items 9 A - C. Commission staff has reviewed the Bureau's reports and concurs with their recommendations.

Chairman Shelton moved to approve the recommendation by the Bureau of Gambling Control for Item 9A. The motion was seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes.

Chairman Shelton expressed concerns regarding Yolanda Smith, Item 9B, and her failure to disclose a conviction on her application. Chairman Shelton indicated that is causing a lot of extra work for the Bureau and the Commission and it's the applicant's responsibility to make the declarations required in the application.

David Tierney Designated Agent indicated he agreed with the Chairman's comments. Mr. Tierney further indicated that when this type of information is brought to their attention they do move to terminate.

Chris Davis Licensing Manager Bureau of Gambling Control indicated they do have a policy allowing the applicant to amend their application

Chairman Shelton moved to approve the recommendation by the Bureau of Gambling Control for Items 9B and 9C. The motion was seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes.

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the applicants in Items 10 A and B, application for requests to withdraw without prejudice. Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

11. Applications for Initial Tribal-State Compact Gaming Resource Supplier Finding of Suitability (Authority Pursuant to the Tribal-State Gaming Compact, section 6.4.5): Gemaco, Inc.: GemGroup, Inc.

Deputy Director Tina Littleton indicated that the Bureau of Gambling Control recommended that the Commission approve the initial finding of suitability application. Commission staff has reviewed the Bureau's report and concurs with their recommendation. Upon motion of Commissioner Shimazu, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the recommendation provided by the Bureau of Gambling Control.

12. Request for Interim Approval of Bingo Card-Minding Devices (Title 4 CCR section 12482)

E-Max Gaming Systems: E-Max Gaming Unit - Model #HH750V1R07; Software Version: V2.9.E-5.

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the bingo card-minding device for the period of April 8, 2009 through April 30, 2010 with the following conditions:

- (1) An interim approval shall be valid for one year from the date it is granted by the Commission or until regulations specifying additional criteria for card-minding devices become effective, whichever is later.
- (2) An interim approval does not obligate the Commission to grant a regular approval and does not create a vested right in the holder to either an extension of the interim approval or to the granting of a subsequent regular approval.
- (3) An interim approval does not in any way change the legal requirement that the applicant bears the burden of establishing that a specific device complies with all of the provisions of paragraphs (1) and (2) of subdivision (p) of section 326.5 of the Penal Code.
- (4) Issuance of an interim approval concerning a specific card-minding device has no bearing on the question of whether the manufacturer of the device, or any affiliated person, will qualify for issuance of any Commission permit, registration, or license. Any interim approval will be cancelled in the event that the manufacturer of the device is subsequently determined to be ineligible for licensure.
- (5) If, during the term of an interim approval, it is determined that any particular card-minding device is not qualified for approval, the Executive Director shall prepare an order to show cause why that device's interim approval should not be cancelled. The manufacturer of the device shall be given at least 30 days to respond in writing. After receipt of the manufacturer's response, the matter shall be set for consideration at a noticed Commission meeting. The manufacturer may address the Commission by way of an oral statement at the Commission meeting and, either in writing not less than ten days prior to the meeting or at the meeting itself, may request an evidentiary hearing.
- (6) Any card-minding device and its designated software version that possess an automatic daubing capability shall have that capability disabled.

Upon motion of Commissioner Shimazu, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.
