MINUTES OF SEPTEMBER 9, 2009 COMMISSION MEETING

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairman Dean Shelton called the meeting to order at 10:01 a.m., and asked everyone to stand for the Pledge of Allegiance.

Roll Call of Commissioners.

Roll Call of Commissioners was taken with Chairman Dean Shelton and Commissioners Stephanie Shimazu, and Alexandra Vuksich present.

3. Approval of Commission Meeting Minutes for: July 21, 2009 & August 3, 2009

Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the meeting minutes for July 21 and August 3, 2009.

4. Request for Temporary Initial State Gambling License (Pursuant to Business and Professions Code section 19824(f):

Marina Club: Guy Calamia and Ki-Sun Calamia Living Trust Ki-Sun Calamia, Grantor / Beneficiary Robert Ward, Trustee

Deputy Director Tina Littleton indicated that the Ki-Sun Calamia, Grantor /Beneficiary application would not be addressed at this time because the staff does not have the investigation report. It would be heard at a future commission meeting.

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the temporary state gambling license for the licensure period of September 9, 2009 through December 31, 2009 with the following conditions:

- 1. The <u>temporary</u> initial license takes effect on the date that the Commission approves the request and expires December 31, 2009. If more time is needed to complete the background process, then the <u>temporary</u> state gambling license can be extended for an appropriate amount of time after consultation with the Bureau.
- 2. Issuance of a <u>temporary</u> license does not obligate the Commission to grant a permanent license. Issuance of a temporary license does not create a vested right in the holder to either extension of the temporary license or to a regular license.
- 3. Issuance of this <u>temporary</u> license does not in any way change the legal requirement that the applicant bears the burden of establishing that he/she is suitable pursuant to Business and Professions (B&P) Code section 19856(a) for a regular license.
- 4. Issuance of this <u>temporary</u> license does not change the license qualification requirements of the Gambling Control Act, including but not limited to B&P Code sections 19856, 19857, 19858, and 19859.
- 5. The applicant has pending applications for regular state gambling licenses. A regular license may or may not be issued, depending upon the results of the complete background investigation and upon the conduct of the applicant and its employees during the term of the <u>temporary</u> license.
- 6. If, during the term of the temporary license, the Executive Director determines that any particular applicant is disqualified for any of the reasons set forth in B&P Code section 19859, the Executive Director shall prepare an order to show cause why that applicant's temporary license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of the temporary licensure not less than five days prior to the meeting. The applicant may request an evidentiary hearing either in writing not less than five days prior to the meeting or at the meeting itself.
- 7. If, during the term of the <u>temporary</u> license, the Executive Director determines that any particular applicant may have violated one or more of the conditions under which the temporary license was issued, the Executive Director shall prepare an order to show cause why that applicant's <u>temporary</u> license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of the temporary licensure not less than five days prior to the meeting. Either in writing not less than five days prior to the meeting or at the meeting itself, the applicant may request an evidentiary hearing.

Commissioner Vuksich asked if the revenue from the club was being held in escrow.

Keith Sharp, representing Guy Calamia and Ki-Sun Calamia Living Trust, indicted the revenue is in escrow and is being distributed in compliance with the previous condition on the Marina Club license.

Commissioner Shimazu asked if the first condition on the Marina Club license had been met regarding the submission of the application for Ki-Sun Calamia and Mr. Sharp indicated it was completed.

Keith Sharp commented on the licensure period of four months for the trust and trustee and recommended extending the licensure period until such time that their permanent application is ready for consideration by the Commission.

Deputy Director Tina Littleton indicated that the four months was to allow legal staff time to determine the extent of implications stemming from the recent court documents that names Ms. Betty Burks as co-owner of the gambling establishment. Ms. Littleton indicated that staff needed a legal determination as to whether the Trust is the 100 percent owner.

Chairman Shelton indicated that barring no opposition from the audience he requested Deputy Director Tina Littleton to read and amend the recommendation to extend for six months.

Deputy Director Tina Littleton indicated that the amended staff recommendation was to approve the temporary state gambling license from September 9, 2009 through March 31, 2010 with the conditions (as listed above).

Mr. Robert Tabor, representing Betty Burks, does not oppose the granting of a temporary license for this Trust; however, believes a permanent license should not be approved until a decision from the court has been rendered. Also, Mr. Tabor requested that the Commission consider placing a condition on the license requiring any distributions made to the beneficiary of the trust, an equal amount is held in escrow or trust on behalf of Ms. Burks until she is licensed by the Commission.

Chairman Shelton indicated that no action would be taken on information presented by Mr. Tabor, until the Commission has received all relevant information..

Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

5. <u>Application for Approval for Initial State Gambling License (Pursuant to Business and Professions Code section 19851 & 19852; Title 4 CCR 12342(a)(8) (Form 143)):</u> Lucky Chances Casino: Lucky Chances, Inc.

Rene and Mila Medina 2008 Irrevocable Blind Trust Agreement Marino D, Gueco, Trustee

Deputy Director Tina Littleton indicated that the Bureau of Gambling Control recommends that the Commission approve the initial state gambling license application to be endorsed on Lucky Chances, Inc's state gambling license. Staff has reviewed the Bureau's reports and concurs with their recommendation.

Both Commissioners Vuksich and Shimazu indicated that they would like to ask Mr. Gueco (the trustee) questions regarding his experience as a trustee and his relationship with the Medinas. Chairman Shelton indicated that he would not vote on this item until Mr. Gueco was present to respond to questions. Mr. Rod Blonien, Designated Agent, indicated that Mr. Gueco, Trustee was out of the country and could not be present.

Upon concurrence of the Commissioners, this item (5), and Item 8 were tabled until the October 8, 2009 commission meeting to enable Mr. Gueco to be present to respond to any questions the Commissioners may have.

Upon request of the Commissioners, Deputy Director Littleton indicated that she would amend the recommendation on Item 6E so that the Commission could consider all the related items together.

- 6. Applications for Renewal of State Gambling Licenses Including All Associated Applicants and Endorsees (Pursuant to Business and Professions Code section 19876):
 - E. Lucky Chances Casino: Lucky Chances, Inc.
 Rommell Medina, Shareholder Ruell Medina, Shareholder

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the renewal state gambling license for the licensure period of October 1, 2009 through October 30, 2009 continuing with the following existing conditions:

- 1. Rene Medina shall be prohibited from entering, being present in, or in any way patronizing (a) the areas within Lucky Chances Casino in which controlled gambling is conducted and (b) any other areas related to the gambling operation, such as count and surveillance rooms, including all of the 2nd floor.
- 2. All future shareholders, corporate officers, key employees, and work permit holders shall be informed of the prohibition (as identified in condition number one) by the General Manager within three business days of their start date. The General Manager shall maintain all records documenting this notification to new employees, etc., for four years following each notification. The General Manager of Lucky Chances shall maintain, for four years, all records documenting the initial action taken following the September 23, 2008, Commission Meeting to inform shareholders, corporate officers, key employees, and work permit holders of condition number one.
- 3. Ruell Medina and Rommel Medina, licensed as shareholders in Lucky Chances, Inc., shall each be individually responsible for ensuring that all conditions placed on the Lucky Chances license are fully complied with, including but not limited to duties placed upon the General Manager.

- 4. If Rene Medina is observed at any time by any employee entering, or being present in, (a) the areas within Lucky Chances Casino in which controlled gambling is conducted or (2) any other areas related to the gambling operation, such as count and surveillance rooms, including all of the 2nd floor, the General Manager or manager in charge shall within 30 minutes telephone (1) the California Gambling Control Commission (Commission), and (2) the Department of Justice, Bureau of Gambling Control (Bureau). The call to the Commission shall be made to the Executive Director at (916) 263-0700. The call to the Bureau shall be made to the Bureau Chief at (916) 263-3408.
- 5. Any communication between Rene Medina and any shareholder or employee of Lucky Chances concerning the operation of the Lucky Chances cardroom business shall be disclosed to the Executive Director and to the Bureau Chief within one business day of the communication. This disclosure requirement applies to both oral and written communications. This disclosure must be made in writing. The General Manager shall maintain records documenting each disclosure for four years following the disclosure.

Deputy Director Littleton indicated that this would be heard again at the October 8, 2009 Commission meeting to coincide with Items 5 and 8 which were tabled.

Upon motion of Chairman Shelton, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

A. Casino Real: Casino Real, Inc.

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the renewal state gambling license for the licensure period of October 1, 2009 through September 30, 2011. Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

B. Ceasar's Club: Jose Alvarez Cahue, Sole Proprietor

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the renewal state gambling license for the licensure period of October 1. 2009 through September 30, 2011. Chairman Shelton moved to extend the renewal state gambling license for the period of October 1, 2009 through October 31, 2009. Chairman Shelton further stated that staff is to notify Mr. Cahue to be present at the next Commission meeting and that his license may be denied. The motion was seconded by Commissioner Vuksich and unanimously carried in a vote by roll call, with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes.

C. Clovis 500 Club: A General Partnership

Deputy Director Tina Littleton indicated that staff recommended that the Commission approve the renewal state gambling license for the licensure period of October 1, 2009 through September 30, 2011. Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

D. La Primavera Pool Hall and Café: Candelario Salas, Sole Proprietor

Deputy Director Tina Littleton indicated that staff recommended that the Commission extend the state gambling license through November 30, 2009 continuing with the following condition:

The gambling establishment will send the Commission, no later than the 15th day of each month, documentation from the Internal Revenue Service (IRS) substantiating compliance with tax repayment obligations. The first report will be due in January 2009 continuing until repayment has been completed.

Upon motion of Commissioner Shimazu, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

F. The Mint: James Podergois, Sole Proprietor

Deputy Director Tina Littleton indicated that staff recommended that the Commission extend The Mint's state gambling license from October 1, 2009 through December 31, 2009 with the following existing conditions.

- 1. Prior to opening the new location, applicant must submit a business license, patron safety and security plan, and an emergency evacuation preparedness plan.
- 2. The Bureau of Gambling Control must conduct a site visit at the new location.

Upon motion of Commissioner Vuksich, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

G. River Card Room: The River Card Room, Inc. John Park, Shareholder

Deputy Director Tina Littleton indicated that staff recommended that the Commission extend the state gambling license through November 30, 2009. Upon motion of Chairman Shelton, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

7. Application for Approval for State Gambling License Including All Associated Applicants and Endorsees – Request to Withdraw (Pursuant to Business and Professions Code section 19851):

Gold Rush Gaming Parlor and Saloon: Philip Chau, Partner, Tenants in Common James Kouretas, Partner, Tenants in Common

Deputy Director Tina Littleton indicated that the staff recommended the Commission approve the requests to withdraw without prejudice. Upon motion of Chairman Shelton, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shimazu and Vuksich voting yes, the Commission approved the staff recommendation.

8. Requests for Additional Permanent Authorized Tables (Pursuant to California Code of Regulations, Title 4, section 12359):

Mr. Rod Blonien, Designated Agent, requested that the Commissioners reconsider their earlier decision to table this item, and the additional tables are essential for Lucky Chances' business. After a brief discussion among the Commissioners, the Commissioners decided not to reconsider their decision to table the request for additional tables until the October 8, 2009 commission meeting.

Upon concurrence of the Commissioners, this item was tabled (see Item 5).
