**MINUTES OF DECEMBER 9, 2010  
COMMISSION MEETING**

**OPEN SESSION**

1. Call to Order and Pledge of Allegiance.

Chairman Dean Shelton called the meeting to order at 10:01 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken, with Chairman Dean Shelton and Commissioners Tiffany Conklin, James Shelby and Stephanie Shimazu present.

3. Approval of Commission Meeting Minutes for :  
November 3, 2010

Upon motion of Commissioner Shelby, seconded by Commissioner Shimazu and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Conklin, Shelby and Shimazu voting yes, the Commission approved the meeting minutes for November 3, 2010.

Deputy Director Tina Littleton indicated that staff recommended the Commission approve the stock redemption agreement allowing Ms. Marlene Trapani to sell the shares held by the Estate of Marko Trapani, Sr. to Timothy Bumb and George Bumb, Jr. with the condition listed below. Ms. Trapani will remain on the license as a Financial Interest Holder through the terms of the agreement.

Deputy Director Tina Littleton indicated that staff recommended the Commission approve the assignment of interest documents allowing Wendy Park to sell her one percent in Cal-Pack Sonoma, LLC, (item 4D) and one percent in The River Cardroom, Inc. (item 4E) to Mr. Richard Shindle.

Upon motion of Chairman Shelton, seconded by Commissioner Conklin and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Conklin, Shelby and Shimazu voting yes, the Commission approved the staff recommendation.

5. Applications for Approval of Initial State Gambling License (Pursuant to Business and Professions Code section 19851):

- A. Hemphill's Cardroom:           Timothy J. Long, Sole Proprietor

Deputy Director Tina Littleton indicated the Bureau of Gambling Control recommended that the Commission approve the initial state gambling license. Staff has reviewed the Bureau's report, concurred with their recommendation, and recommended approval for the licensure period of December 9, 2010 through December 31, 2012 with the following conditions:

1. *Prior to opening for business, Timothy Long, Sole Proprietor of Hemphill's Cardroom, must submit the following documentation to the California Gambling Control Commission:*
  - a. *An updated Cardroom Supplemental Information for State Gambling License Rev. 4/08 (BGC-APP-015C) reflecting the new address of the gambling establishment;*
  - b. *A business license issued by the City of Napa;*
  - c. *A reviewed and approved Patron Safety and Security Plan;*
  - d. *An Emergency and Evacuation Plan, including approval from the responsible local authority;*
  - e. *A lease (if applicable); and,*
  - f. *Chart of Accounts.*

Rod Blonien, representing Timothy Long and Hemphill's Cardroom, made a presentation detailing the time line of events during the licensing process as well as responding to outstanding money owed to Mr. Brian Altizer. In summary, Mr. Blonien argued that Brian Altizer was trying to stop the licensing of Timothy Long so that he would not have to fulfill the contractual agreement to purchase Hemphill's.

Mr. Keith Sharp, representing BVK Gaming and Brian Altizer indicated that they were requesting the Commission deny the licensing of Timothy Long based on two premises.

Mr. Sharp stated the first premise was that there is no license to grant; second, that Mr. Long is unsuitable under the essential requirements of the Gambling Control Act to be a licensee. Mr. Sharp continued his argument detailing his reasons Mr. Long is unsuitable to hold a state gambling license.

Commissioner Conklin asked if the \$10,000 check was a personal check and what dates it was written and later payment stopped.

Mr. Blonien indicated the check was written on the account of Tim and Terry Long. It was issued May 3, 2008 and the stop payment was October 6, 2008. Mr. Blonien reiterated the check was a gift and Mr. Blonien stated he had a witness to Mr. Altizer stating he would not cash it.

Mr. Sharp indicated it was not cashed because Mr. Altizer was waiting until close of escrow so that Mr. Long would have the funds to cover the check.

Mr. Brian Altizer presented various examples of his dealings with Mr. Long and alleged that Mr. Long still owed him money that was not credited in escrow and half of the settlement of the lawsuit. Mr. Altizer summed up by saying he did not agree with many of the statements made at the meeting concerning his financial dealings with Timothy Long.

Commissioner Conklin moved to approve staff recommendation.

Mr. Anthony Pilotti addressed the Commission stating that he does not oppose the gaming license, but that Mr. Long does owe him and Mr. Bruce Meyers money. Commissioner Shelby stated that upon reviewing the documentation, he has a hard time finding a reason for financial suitability.

Commissioner Shimazu stated that upon her review of the documents provided, she doesn't feel there is enough to be found," not suitable," but there are still a lot of outstanding issues and no documents to corroborate what individuals have stated today.

Chairman Shelton stated that this has nothing to do with the upcoming regulations because they are not currently in place. The Chairman further indicated that he did not appreciate the Commission being put in a position to be a collection agency. Chairman Shelton indicated upon his review of the background investigation, he could not approve the license.

Commissioner Conklin's motion failed due to a lack of a second.

Commissioner Shelby indicated that he could find no basis for financial suitability to grant a license and moved to deny the license. The motion was seconded by Chairman Shelton.

Mr. Blonien requested the Commission consider attaching a condition to the license requiring that the matter be submitted to mediation and/or arbitration and issue the license. If there is a finding that Mr. Long owes Mr. Altizer money, that he be required to pay it within 60 days. Mr. Blonien clarified that he was requesting a license for nine months with the requirement that the parties to submit it to mediation or arbitration and upon the findings of that, pay what is owed.

Mr. Paul Carey, attorney and friend of Mr. Long, indicated that the parties are contractually committed to cooperate with each other to get approval of the license in Mr. Long's name, so that the contract can be performed and the license purchased by Mr. Altizer. Mr. Carey argued that Mr. Altizer is trying to interfere with this approval so that Mr. Long cannot sell him the license, and Mr. Altizer will have the only cardroom in Napa County.

Commissioner Shimazu stated that the Commission was well aware of what was going on and that they are focusing on the suitability. The issues are that the Bureau did recommend approval, but there have been statements today that indicated that maybe the Commission doesn't have all the documentation and maybe there are other loans that the Commission doesn't know about. That is what causes concerns.

Commissioner Shelby stated that he could only go by what was provided to him by the Bureau and on that basis could not see the financial suitability to approve the license.

Mr. Carey indicated that if the approval is conditioned upon the performance of the sale to Mr. Altizer, who does qualify, who is financially suitable, that concern disappears.

Commissioner Conklin indicated that Mr. Long is contractually obligated to sell Hemphill's to Mr. Altizer. In Commissioner Conklin's opinion, Mr. Long's financial suitability does not come into consideration.

Upon the motion by Commissioner Shelby to deny, seconded by Chairman Shelton and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Shelby and Shimazu voting yes and Commissioner Conklin voting no, the Commission denied the initial license.

Deputy Director Tina Littleton indicated the Bureau of Gambling Control recommended the Commission approve the initial application in items 5B and 5C. Staff has reviewed the Bureau's report, concurred with their recommendation, and

recommended approval for endorsement through the remainder of the licensure periods.

Upon motion of Commissioner Shelby, seconded by Chairman Shelton and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Conklin, Shelby and Shimazu voting yes, the Commission approved the staff recommendation.

Deputy Director Tina Littleton indicated the Bureau of Gambling Control recommended that the Commission approve the initial application. Staff has reviewed the Bureau's report, concurred with their recommendation, and recommended approval for the licensure period of December 9, 2010 through December 31, 2012, removing all temporary conditions as follows:

1. *The temporary initial license takes effect on the date that the Commission approves the request and expires May 31, 2011. If more time is needed to complete the background process, then the temporary state gambling license can be extended for an appropriate amount of time after consultation with the Bureau.*
2. *Issuance of a temporary license does not obligate the Commission to grant a permanent license. Issuance of a temporary license does not create a vested right in the holder to either extension of the temporary license or to a regular license.*
3. *Issuance of this temporary license does not in any way change the legal requirement that the applicant bears the burden of establishing that he/she is suitable pursuant to Business and Professions (B&P) Code section 19856(a) for a regular license.*
4. *Issuance of this temporary license does not change the license qualification requirements of the Gambling Control Act, including but not limited to B&P Code sections 19856, 19857, 19858, and 19859.*
5. *The applicant has pending applications for regular state gambling licenses. A regular license may or may not be issued, depending upon the results of the complete background investigation and upon the conduct of the applicant and its employees during the term of the temporary license.*
6. *If, during the term of the temporary license, the Executive Director determines that any particular applicant is disqualified for any of the reasons set forth in B&P Code section 19859, the Executive Director shall prepare an order to show cause why that applicant's temporary license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of*

*the temporary licensure not less than five days prior to the meeting. The applicant may request an evidentiary hearing either in writing not less than five days prior to the meeting or at the meeting itself.*

- 7. If, during the term of the temporary license, the Executive Director determines that any particular applicant may have violated one or more of the conditions under which the temporary license was issued, the Executive Director shall prepare an order to show cause why that applicant's temporary license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of the temporary licensure not less than five days prior to the meeting. Either in writing not less than five days prior to the meeting or at the meeting itself, the applicant may request an evidentiary hearing.*

Upon motion of Commissioner Shelby, seconded by Commissioner Conklin and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Conklin, Shelby and Shimazu voting yes, the Commission approved the staff recommendation.

Deputy Director Tina Littleton indicated staff recommended the Commission extend the temporary state gambling license through June 30, 2011, revising condition number one and continuing with conditions two through seven, as listed in the following:

**Existing Condition Number One:**

- 1. The temporary initial license takes effect on the date that the Commission approves the request and expires December 31, 2010. If more time is needed to complete the background process, then the temporary state gambling license can be extended for an appropriate amount of time after consultation with the Bureau.*

**Revised Condition Number One:**

- 1. The temporary initial license takes effect on the date that the Commission approves the request and expires June 30, 2011. If more time is needed to complete the background process, then the temporary state gambling license can be extended for an appropriate amount of time after consultation with the Bureau.*

**Continue Conditions Number 2 – 7:**

2. *Issuance of a temporary license does not obligate the Commission to grant a permanent license. Issuance of a temporary license does not create a vested right in the holder to either extension of the temporary license or to a regular license.*
3. *Issuance of this temporary license does not in any way change the legal requirement that the applicant bears the burden of establishing that s/he is suitable pursuant to Section 19856(a) for a regular license.*
4. *Issuance of this temporary license does not change the license qualification requirements of the Gambling Control Act, including but not limited to Sections 19856, 19857, 19858, and 19859.*
5. *The applicant has an application pending for a regular state gambling license. A regular license may or may not be issued, depending upon the results of the complete background investigation and upon the conduct of the applicant and its employees during the term of the temporary license.*
6. *If, during the term of the temporary license, the Executive Director determines that any particular applicant is disqualified for any of the reasons set forth in Business and Professions Code section 19859, the Executive Director shall prepare an order to show cause why that applicant's temporary license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of the temporary licensure not less than five days prior to the meeting. Chief Counsel Joe Dhillon indicated that Bill Williams from IGLS and Robert Tabor were present to represent Gloria's.

Robert Tabor, representing Gloria's, indicated that there two key issues in the stipulated settlement. The first issue is the appropriateness of the fines and or fees assessed against the licensee. Mr. Tabor argues that the licensee is suffering the ultimate fine which is the revocation of her license. Mr. Tabor stated that the second issue was if the sale of Gloria's would be drawn out over years. Mr. Tabor stated that there is a contract that has been signed and if the settlement is approved, GLCR Inc. (the purchaser of Gloria's) will file their temporary licensing application within a week. At the same time GLCR Inc. will be requesting an amendment of their Articles of Incorporation to include appropriate gaming language. Mr. Tabor added that the owners of GLCR Inc. are current licensees as the primary shareholders of Club One Casino.

Mr. Bill Williams indicated that he believed they reached a reasonable agreement with the respondent in this case. Ms. Gutierrez is accepting all of the charges in the Statement of Issues as the final disposition of the case. Mr. Williams requested the Commission approve the settlement.
