**MINUTES OF JUNE 30, 2011
COMMISSION MEETING**

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairperson Stephanie Shimazu called the meeting to order at 10:01 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken, with Chairperson Stephanie Shimazu and Commissioners Tiffany Conklin and Lauren Hammond present.

3. Approval of Commission Meeting Minutes for :
May 26, 2011

Upon motion of Commissioner Conklin, seconded by Commissioner Hammond and unanimously carried in a vote by roll call with Chairperson Shimazu and Commissioners Conklin and Hammond voting yes, the Commission approved the meeting minutes for May 26, 2011.

4. Consideration to Extend the Temporary State Gambling License (Pursuant to Business and Professions Code section 19824(f)):

Bankers Casino: Cap's Enterprises, Inc.

Hector Campos, Vice President, Shareholder

Licensing Manager Marianne Estes indicated that staff recommended the Commission approve the extension of the temporary state gambling license for six months, through December 31, 2011, revising condition number one and continuing with conditions two through seven as follows:

Existing Condition Number One:

1. *The temporary initial license takes effect on the date that the Commission approves the request and expires June 30, 2011. If more time is needed to complete the background process, then the temporary state gambling license can be extended for an appropriate amount of time after consultation with the Bureau.*

Revised Condition Number One:

1. The temporary initial license takes effect on the date that the Commission approves the request and expires December 31, 2011. If more time is needed to complete the background process, then the temporary state gambling license can be extended for an appropriate amount of time after consultation with the Bureau.

Continue Conditions Number 2 – 7:

2. Issuance of a temporary license does not obligate the Commission to grant a permanent license. Issuance of a temporary license does not create a vested right in the holder to either extension of the temporary license or to a regular license.
3. Issuance of this temporary license does not in any way change the legal requirement that the applicant bears the burden of establishing that s/he is suitable pursuant to Section 19856(a) for a regular license.
4. Issuance of this temporary license does not change the license qualification requirements of the Gambling Control Act, including but not limited to Sections 19856, 19857, 19858, and 19859.
5. The applicant has an application pending for a regular state gambling license. A regular license may or may not be issued, depending upon the results of the complete background investigation and upon the conduct of the applicant and its employees during the term of the temporary license.
6. If, during the term of the temporary license, the Executive Director determines that any particular applicant is disqualified for any of the reasons set forth in Business and Professions Code section 19859, the Executive Director shall prepare an order to show cause why that applicant's temporary license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of the temporary licensure not less than five days prior to the meeting. Either in writing not less than five days prior to the meeting or at the meeting itself, the applicant may request an evidentiary hearing.
7. If, during the term of the temporary license, the Executive Director determines that any particular applicant may have violated one or more of the conditions under which the temporary license was issued, the Executive Director shall prepare an order to show cause why that applicant's temporary license should not be cancelled, which shall be considered at the first available noticed Commission meeting. The applicant may address the Commission by way of an oral statement at the noticed Commission meeting and/or may submit documents in support of the temporary licensure not less than five days prior to the meeting. Either in writing not less than five days prior to the meeting or at the meeting itself, the applicant may request an evidentiary hearing.

Commissioner Conklin requested the Bureau comment on why the process seems to have taken excessively long with this company.

Chris Davis, Bureau of Gambling Control indicated that the Bureau had waited a long time for information significant to the case and there were also workload issues with the audit team allowing only limited resources to complete the financial background. Ms. Davis further indicated that the Bureau has completed their report and answered the questions raised by Commission staff.

Licensing Manager Marianne Estes stated that the staff has received the report and are analyzing the responses to the questions to ensure they are complete and accurate and staff intends to bring it to the Commission within one to two months.

Upon motion of Commissioner Hammond, seconded by Commissioner Conklin and unanimously carried in a vote by roll call with Chairperson Shimazu and Commissioners Conklin and Hammond voting yes, the Commission approved the staff recommendation.

5. Application for Approval of Renewal of State Gambling Licenses (Pursuant to Business and Professions Code section 19876):

Ocean's Eleven Casino: Ocean's Eleven Casino General Partnership
Haig Kelegian, Jr., Partner

Licensing Manager Marianne Estes indicated that staff recommended the Commission deny the renewal application.

Mr. Keith Sharp, representing Haig Kelegian, Jr., addressed the Commission indicating he was recently retained to represent Mr. Kelegian, Jr. Mr. Sharp stated that this case appears to be a totality of circumstances and having the opportunity to discuss each circumstance individually with staff would perhaps allow Mr. Sharp to return to the Commission with a new staff recommendation. Mr. Sharp proceeded to request an extension of the license to afford time to address the concerns of the staff.

Commissioner Conklin stated that Mr. Kelegian, Jr. notified the Bureau on December 2nd of his intention of getting a gaming license in Washington State and asked the Bureau when they notified Mr. Kelegian, Jr. that this could be a problem.

Chris Davis, Bureau of Gambling Control indicated she would need to research this question.

Mr. Sharp indicated that was one of the issues they wanted to discuss; there was a notification, but it was very late in the process, after the transaction was completed.

Mr. Haig Kelegian, Jr. indicated that he had not received any notification from the Bureau of Gambling Control nor the Commission regarding a possible problem with acquiring a license in the state of Washington.

Chairperson Shimazu indicated that at this time she did not see what would change the staff recommendation including the total divesting of the one percent interest in the Washington business. Chairperson Shimazu stated that the one percent wasn't the issue as much as, the control of, or indirectness of, the investment. Chairperson Shimazu further indicated that after reviewing the documents, it appeared that Mr. Kelegian, Jr. was going to be running the business.

Mr. Sharp stated that in his opinion there is some misinterpretation because the Gambling Control Act does not give guidance when looking at terms such as control and indirect. Mr. Sharp requested the opportunity to re-craft how Mr. Kelegian, Jr. is involved with the Washington State business in a way that may be more acceptable to the Commission's interpretation of 19858.5

Commissioner Hammond indicated that at this time she supports the staff's recommendation; however, she was also open to giving Mr. Kelegian, Jr. more time to attempt resolution of his one percent investment.

Chairperson Shimazu asked Commission staff if they concurred with the possible extension.

Executive Director Tina Littleton stated that staff would be open to extending the license to afford the opportunity to explore the options. Ms. Littleton indicated that it would be important to hear the Commission's concerns and assess, if any, on his license, if Mr. Kelegian, Jr. were to divest his one percent and his wife were to take full ownership.

Chairperson Shimazu indicated that there would be other factors that need to be considered as well as that one item.

Commissioner Hammond indicated that her concern was that an extension would result in further delays and indicated she was not interested in a 90 day extension and asked Mr. Sharp what was reasonable. Mr. Sharp indicated 60 days.

Mr. Kelegian, Jr. addressed the Commission indicating he does not live in Washington, does not run the casino and even if he divests his one percent; he would still be working as a consultant and working at the operation. Mr. Kelegian, Jr. stated that he understood it is an ownership and control issue and reiterated he does not control the company; the company is 99 percent owned by his wife, who makes all the decisions. Mr. Kelegian, Jr. stated he assisted with the applications and forms because he has the experience. Mr. Kelegian, Jr. further indicated that there is a management staff that runs the investment and that is all it is, an investment.

Commissioner Conklin stated that she can appreciate the situation but the documentation before the Commission looks illusory at best. Commissioner Conklin further indicated she was in complete agreement to allow 60 more days but that she cautioned Mr. Kelegian Jr. to use the time appropriately and consider removing himself totally from the business in Washington.

Mr. Haig Kelegian, Sr. addressed the Commission commenting that his son and daughter-in-law do not live in Washington and do not run the casino. They have a management staff that runs the business. Mr. Kelegian, Sr. shared his concerns that this is not an isolated issue. His son notified the Bureau of Gambling Control of his interest in getting a gaming license in Washington State and, in the interest of full disclosure, provided all the documentation for their review; however, his son did not receive any communication from the Bureau or Commission indicating there was a problem until almost five months later. By that time the transaction had taken place. Mr. Kelegian, Sr. indicated that depending on how the Commission interprets "involvement" this could become a more serious problem because there are many one percent owners in the industry throughout the country.

Chairperson Shimazu moved to extend the renewal license for 60 days. The motion was seconded by Commissioner Conklin and unanimously carried in a vote by roll call with Chairperson Shimazu and Commissioners Conklin and Hammond voting yes, the Commission approved the staff recommendation.

Licensing Manager Marianne Estes indicated that the Bureau of Gambling Control recommended that the Commission approve the initial applications in items 6A through 6E. Staff has reviewed the Bureau's reports and concurred with their recommendations.

Upon motion of Commissioner Hammond, seconded by Commissioner Conklin and unanimously carried in a vote by roll call with Chairperson Shimazu and Commissioners Conklin and Hammond voting yes, the Commission approved the staff recommendation.

7. Applications for Approval of Renewal Key Employee Portable Personal License (Pursuant to Business and Professions Code section 19854):
 - A. Hoa Nguyen

Licensing Manager Marianne Estes indicated that staff recommended the Commission deny the renewal application. Ms. Estes further indicated that on Monday, June 27, 2011, Commission staff received a letter from Mr. Nguyen requesting an evidentiary hearing should the Commissioners vote to deny his application.

Ms. Lyna Nguyen addressed the Commission on behalf of Hoa Nguyen to assist as a language interpreter. Ms. Lyna indicated that Mr. Nguyen has been employed at the Oaks Card Club for 15 years and other casinos prior to the Oaks. Ms. Nguyen stated that the Oaks Card Club terminated Mr. Nguyen based on untrue accusations. Ms.

Nguyen continued stating that the case is going to federal court and upon the advice of his attorney; Mr. Nguyen could not talk about the case. Ms. Nguyen requested the Commission not deny Mr. Nguyen's license because he needed it to be able to work at any casino. Ms. Nguyen indicated that Mr. Nguyen is not currently working.

Commissioner Hammond asked if Mr. Nguyen had the authority to set up the Pai Gow tables at the Oaks Card Club. Ms. Nguyen responded stating that Mr. Nguyen could not answer that question due to the pending court case.

Chief Counsel Joe Dhillon stated that should the Commission deny Mr. Nguyen's renewal, Mr. Nguyen would still be able to work through the completion of the administrative hearing process.

Chairperson Shimazu and Commissioner Conklin expressed concerns regarding the briefness of the Bureau's report and asked the Bureau to provide additional information regarding his termination status or an independent assessment of his involvement.

Aaron Wong, Bureau of Gambling Control indicated that the Bureau could not disclose much information on Mr. Nguyen's involvement due to the fact that there is still an ongoing investigation.

Commissioner Conklin moved to approve the renewal application. This motion failed due to the lack of a second.

Chairperson Shimazu moved to direct the renewal application to an administrative hearing with Commissioners present. The motion was seconded by Commissioner Hammond, however, failed due to the lack of affirmative votes.

The discussion ensued regarding the Commission's possible options and what effect it would have on Mr. Nguyen's ability to work and also what information may become available through the administrative hearing process that would assist the Commissioners.

Upon concurrence of the Commissioners and staff, the item was held for further discussion later in the meeting.

B. Larry Thomas

Licensing Manager Marianne Estes indicated that staff recommended the Commission approve the renewal application valid through June 30, 2013.

David Fried, representing the Oaks Card Club, indicated that Mr. Thomas was working and that is why he was unable to attend.

Upon motion of Chairperson Shimazu, seconded by Commissioner Conklin and unanimously carried in a vote by roll call with Chairperson Shimazu and

Commissioners Conklin and Hammond voting yes, the Commission approved the staff recommendation.

Deputy Attorney General Neil Houston addressed the Commissioners indicating he was in support of the settlement. Mr. Houston referenced a letter from Derry Knight to Russell Johnson, dated April 13, 2011 that outlined the rationale of the settlement. Mr. Houston further commented on the similarities of this case and the Merced Poker Room.

Robert Tabor on behalf of GLCR, Inc. indicated that GLCR, Inc. has had a purchase agreement with Mr. Cahue since August of 2010. Mr. Tabor requested the Commission approve this settlement so that GLCR, Inc. can move forward with the acquisition. Mr. Tabor stated that GLCR, Inc. is looking for a new location for the club in Watsonville and that if the settlement is approved, GLCR, Inc. could have applications submitted within two months. Mr. Tabor spoke on behalf of Mr. Cahue and his attorney stating that they are fully in support of the settlement.
