**MINUTES OF JANUARY 6, 2015
COMMISSION HEARING**

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairman Lopes called the meeting to order on January 6, 2015, at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken, with Chairman Richard Lopes and Commissioners Tiffany Conklin, Lauren Hammond and Richard Schuetz present.

3. Hearing Pursuant to Business and Professions Code Sections 19870 and 19871 and CCR, Title 4, section 12050(b)(2):
In the Matter of the Application for Renewal of State Gambling License for La Primavera Pool Hall and Café, Candelario Salas, Sole Proprietor, (CGCC Case No. 2009-12-03-02)
