 - ii. Naseem Salem is required to secure the Staats approval in advance of the hiring and firing of all key employees and supervisors at the Palomar. This approval shall be documented in writing.
 - iii. Naseem Salem is required to secure the Staats approval in advance of the hiring and firing of all employees that are related to Naseem Salem, either by blood or marriage. This approval shall be documented in writing.
 - iv. Naseem Salem is required to secure the Staats approval in advance of entering into any contracts involving the Palomar exceeding \$10,000 or which have significant impact on the Palomar's operations. This approval shall be documented in writing.
- c. To the extent that Naseem Salem is unable to work with the Staats under subsection (b) due to the lack of capacity of the Staats or his inability to communicate with the Staats, Naseem Salem must immediately notify the Bureau of his inability to comply with this condition.
