MINUTES OF JUNE 23, 2016 COMMISSION MEETING

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairman Evans called the meeting to order at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

Chairwoman Erica Pinto expressed her thanks for all of the hard work that went into issuing the licenses and that the tribe looks forward to opening their project later this year.

Chairman Evans wished the members good luck and said that he appreciated the Tribal members attending the meeting.

 Request for Approval of Member for Selection to the Gaming Policy Advisory Committee (Pursuant to Business and Professions Code section 19817): Tom Hallinan, Public Member

Stacey Luna Baxter provided a brief history of her recruitment efforts in seeking an individual for the vacant Public Member seat that had no financial ties to the gambling industry and is a true Public Member, as directed by the Commissioners on February 25, 2016. Ms. Luna Baxter stated that five applications were received and all five applicants were interviewed by an interview panel, pursuant to the Gaming Policy Advisory Committee Selection Criteria. The interview panel recommended Tom Hallinan for selection to the Public Member seat. Ms. Luna Baxter concluded by stating that Mr. Hallinan was in the audience.

Commissioner To acknowledged and thanked Executive Director Luna Baxter for readvertising the position. Commissioner To also stated that he appreciated all the hard work that went into finding the right candidate.

Commissioner Conklin disclosed that Mr. Hallinan works for the firm that represented her former employer, Mr. Churchill, when she worked at DLI Piper. She then stated that she was confident in her ability to make an impartial decision. Therefore, Commissioner Conklin did not recuse herself from the item.
