MINUTES OF FEBRUARY 23, 2017 COMMISSION MEETING

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairman Evans called the meeting to order at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners was taken with Chairman Jim Evans and Commissioners Lauren Hammond, Paula LaBrie and Trang To present.

Executive Director Stacey Luna Baxter welcomed the newest member to the Commission team. Adrianna Alcala-Beshara. Ms. Alcala-Beshara will be the new Deputy Director of Licensing. Executive Director Luna Baxter then stated that the current Deputy Director of Licensing, Katherine Ellis, will be retiring and her last day will be March 30, 2017. Executive Director Luna Baxter expressed that the Commission is lucky to have Deputy Director Ellis. Ms. Alcala-Beshara will become the Deputy Director of Licensing beginning in April. Executive Director Luna Baxter then explained that during the transition period, Deputy Director Ellis will be providing shadowing time and training for Ms. Alcala-Beshara. Executive Director Luna Baxter then discussed some of Ms. Alcala-Beshara's experience and background. Ms. Alcala-Beshara possesses investigative and licensing experience, as well as experience managing multi-billion dollar heath care programs. Ms. Alcala-Beshara joins the Commission from the Department of Health Care Services. Executive Director Luna Baxter also stated that Ms. Alcala-Beshara is an attorney and for a few years had her own law firm. Ms. Alcala-Beshara's legal experience will be invaluable as Deputy Director of Licensing. In conclusion, Executive Director Luna Baxter stated that if the audience has a chance, attendees could meet Ms. Alcala-Beshara after the meeting.

Yolanda Morrow, Assistant Bureau Chief, Bureau of Gambling Control Tony York, Audit and Compact and Compliance Section, Bureau of Gambling Control

Tony York, from the Audit and Compact Compliance Section of the Bureau stated that he and his colleague checked the bad debt of the cardroom and received a list of the people who are connected with the cardroom and have a line of credit. They then reviewed the list to research if they were in compliance of the local ordinance. After their review, they concluded that they were in compliance. Mr. York also stated that if a person with a line of credit defaults, the cardroom would then not issue any more credit for 90-days, unless they pay off the debt in full. Commissioner LaBrie asked Mr. York about the three individuals that did not pay their debt. Mr. York stated that the three individuals left town without paying their debt which was between 60 and 80 thousand dollars.

Designated Agent Keith Sharp stated that there are no regulations that prohibit extending a line of credit to owners. The local ordinance does allow for this line of

credit for gambling patrons as well. Mr. Sharp stated that he spoke to the owners of Marina Club and they said that the debt is largely older money and the Calamias put a prohibition on this debt. If the Commission wants to freeze the line of credit the Calamias would not have an issue with it.

Commissioner Hammond made a motion to approve the initial state gambling license with the condition that there is a freeze on the line of credit to owners and employees until the debt is paid and that the Commission receives updates.

After further discussion, Commissioner Hammond withdrew her motion, and made and submitted a new motion to approve the initial state gambling license with the condition that there is a freeze on the line of credit to owners, family and staff above a \$10,000 threshold and a report to the Bureau on the debt every 90 days. The Chairman asked the Bureau if they were ok with the condition and Assistant Bureau Chief Morrow responded that they were comfortable with the condition.
