# MINUTES OF JULY 27, 2017 COMMISSION MEETING

## <u>OPEN SESSION</u>

1. Call to Order and Pledge of Allegiance.

Chairman Evans called the meeting to order at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken with Chairman Jim Evans, Commissioner Lauren Hammond, Commissioner Paula LaBrie, and Commissioner Trang To present.

3. <u>Approval of Commission Meeting Minutes for:</u> June 28, 2017-GCA Hearing

Upon motion of Commissioner Hammond seconded by Commissioner To and unanimously carried in a vote by roll call with Chairman Evans, Commissioner LaBrie, Commissioner Hammond, and Commissioner To voting yes; the Commission approved the minutes for June 28, 2017 – GCA Hearing.

- 1. **Legend on Stock Certificate.** Approval is be conditioned upon the parties confirming to the Commission, with a copy to the Bureau, within 15 days after the closing that any certificate evidencing the Stock is legended in accordance with the provisions of Business and Professions Code 19882, subdivision (c).
- 2. Additional Legend on Stock Certificate. Within 15 days after the closing, HPCC Holdings, LLC shall provide, to the Bureau and Commission, the certificates evidencing the Stock include the following legend:

THIS CERTIFICATE REPRESENTS SHARES OF STOCK ISSUED BY A CORPORATION THAT HOLDS A GAMBLING LICENSE PURSUANT TO THE LAWS OF THE STATE OF CALIFORNIA. THE STOCK MAY NOT BE TRANSFERRED, ASSIGNED, SOLD, PLEDGED, HYPOTHECATED, OR DISPOSED OF WITHOUT THE PRIOR APPROVAL OF THE CALIFORNIA GAMBLING CONTROL COMMISSION OR ITS SUCCESSOR

- 3. Legend on Certificates Evidencing Membership Interest in HPCC Holdings, LLC. HPCC Holdings, LLC shall confirm to the Commission, with a copy to the Bureau, within 15 days after the closing that all certificates evidencing the membership interests that were issued previously have been so legended.
- 4. Additional Legend on Certificates Evidencing Membership Interests in HPCC Holdings, LLC. HPCC Holdings, LLC shall confirm to the Commission, with a copy to the Bureau, within 15 days after the closing, that any certificates evidencing the membership interests that were issued include the following legend:

THIS CERTIFICATE REPRESENTS A MEMBERSHIP INTEREST ISSUED BY A LIMITED LIABILITY COMPANY THAT HOLDS A

GAMBLING LICENSE PURSUANT TO THE LAWS OF THE STATE OF CALIFORNIA. THE MEMBERSHIP INTEREST MAY NOT BE TRANSFERRED, ASSIGNED, SOLD, PLEDGED, HYPOTHECATED, OR DISPOSED OF WITHOUT THE PRIOR APPROVAL OF THE CALIFORNIA GAMBLING CONTROL COMMISSION OR ITS SUCCESSOR.

5. No Material Change in the Contemplated Transactions. HPCC Holdings, LLC and Stockbridge HP Casino Holdings Company, LLC, either jointly or separately, shall confirm in writing to the Commission, with a copy to the Bureau, that the parties made no material changes to the transaction and the transaction was substantially the same as approved by the Commission. At the same time, HPCC Holdings, LLC, shall deliver to the Commission and the Bureau a copy of a full set of the executed SPA and Lease, as well as any exhibits thereto, and any documents from the closing.

Designated Agent Goodson had previously asked in item 5A for clarification in the licensing memo for item 5C. Mr. Goodson stated that in the Commission staff memorandum, the language sounded ambiguous and just wanted clarification on what would occur if the Temporary License was granted today and the title has not passed.

For the record, Chief Counsel Vlaanderen stated that the procedural process is not to issue a new certificate until the Commission has verification of the (lawful) transfer. From a legal standpoint, if in fact the Commission approves this item, the Temporary License is approved today, but the license certificate itself is not amended or changed until there is verification of the transfer (the conditions for the transactions are met).

## Action:

Upon motion of Commissioner LaBrie seconded by Commissioner To and unanimously carried in a vote by roll call with Chairman Evans, Commissioner Hammond, Commissioner LaBrie and Commissioner To voting yes; the Commission approved the Temporary State Gambling License through July 31, 2018, with the conditions noted below:

- 1. This temporary license takes effect on the date that the Commission approves the request and expires on July 31, 2018. This temporary license is not subject to renewal and may be extended only by order of the Commission at its discretion, but in no case shall this temporary license exceed 24 months. Upon issuance or denial of a regular license, this temporary license shall become invalid.
- 2. Issuance of this temporary license does not obligate the Commission to grant a regular license. Issuance of this temporary license does not create a vested right in the holder to either extension of the temporary license or to a regular license.
- 3. Issuance of this temporary license does not does not change the license qualification requirements of the Gambling Control Act, including the legal requirement that the burden of proving his or her qualifications to receive any license is on the applicant.
- 4. The Commission, when evaluating the applicant's pending application for a regular state gambling license, will consider the conduct of the applicant and its employees, if applicable, during the term of the applicant's temporary license.
- 5. Notwithstanding any other limitations on this temporary license, it is also subject to the discipline and penalties provided in Article 10 and Article 11 of the Gambling Control Act. The issuance of this temporary license is without prejudice to the Bureau's prosecution of an accusation.
- 6. The granting of this temporary license in no way diminishes the responsibilities or powers of the Bureau in enforcing the Gambling Control Act and other applicable laws and regulations with respect to the temporary license.
- 7. This temporary license will only be valid as long as an application for a regular license is currently pending.
- 8. The holder of this temporary license shall pay all applicable fees associated with that license as if the temporary were a regular license.

- 9. If a regular license is not issued within the valid time period of the temporary license, the temporary licensee may submit a request for a new temporary license.
- 10. Upon issuance or denial of a regular license, this temporary license shall become invalid.
- 11. The holder of a temporary license shall comply with all applicable provisions of the Gambling Control Act and Commission and Bureau Regulations.
- 12. The Commission may impose additional conditions to this temporary license in its sole discretion at any noticed public meeting. The imposition of additional conditions does not entitle the temporary licensee to an evidentiary hearing under the Gambling Control Act or Commission regulations.

Mr. Antonino responded to the Commission's questions on the history of the trust, and the distribution of proceeds. Mr. Antonino admitted that his initial understanding was that Ms. Daniels was to not have shares in JLJ2D, Inc., but thought it was permissible to share the funds in a comingled account. Mr. Antonino took ownership for his actions in making the unlawful distributions stating he was unaware this was not allowed, but upon learning he was not supposed to do so, he ceased doing so in 2015, and has not made such distributions since, including to himself. Mr. Antonino stated he has hired counsel to ensure compliance in the future. Bureau of Gambling Control ("Bureau") Assistant Director Morrow confirmed the payments ceased in 2015. Mr. Antonino confirmed that his family's involvement in the cardroom is only as a limited partner shareholders with no involvement in the cardroom itself.

Commissioner To and Chairman Evans stated that prior to hearing from Mr. Antonino, with the blatant violation of the law (not to share proceeds with Ms.

Daniels), they were inclined to refer the matter to evidentiary hearing. However, based on the response received from Mr. Antonino, and confirmation that the proceeds ceased distribution in 2015 they would support approval.

Bureau Assistant Director Morrow confirmed the reasons the Bureau recommended approval were the reasons discussed, along with the longevity of time that the Bureau took on this matter.

Designated Agent Keith Sharp explained that marketing agreements are groups who have players that like to play, and enter into contracts with casinos to have these players play at their casinos. These groups host parties, and wine and dine the players to enhance the play of the games. Mr. Sharp confirmed the groups are paid directly by the Cardrooms and indicated he had recently sent correspondence to the Commission and Bureau urging regulatory process for these marketing agreements also known as promotional groups. Mr. Sharp confirmed he had conferred with Executive Director Stacey Luna Baxter and the issue will be discussed at the next GPAC (Gaming Policy Advisory Committee) meeting. Chairman Evans commented he had also discussed the matter with Executive Director Luna Baxter and agreed the matter should be further developed. Executive Director Luna Baxter stated she has not shared Mr. Sharp's correspondence Commissioner's yet as it was just received yesterday, however the matter is on the agenda for the next GPAC meeting. Bureau Assistant Director Morrow confirmed that the Bureau will be part of the discussions at GPAC to present to the Commission and get regulations started.

Deputy Attorney General Diedrich and Commission Chief Counsel Vlaanderen confirmed that pursuant to the terms of the settlement agreement that the Commission approved there would be no extensions and the license will be revoked in April 2018. Chairman Evans asked Mark Adam if he understood the conditions listed on his license. Mr. Adam stated that he understood the conditions.

## **Existing Conditions:**

- A. Respondent shall obey all federal, state, and local laws, including, but not limited to the Act, the regulations promulgated thereunder and all other laws applicable to controlled gambling.
- B. Respondent or a properly licensed key employee must be present in the gambling establishment at all time it is open for business. There shall be no exceptions.
- C. A violation of any of the above conditions will result in the lifting of the stay and the immediate and automatic revocation of Respondent's state gambling license.

## **New Conditions:**

- D. Mr. Adam's State Gambling License shall be immediately and automatically revoked with a stay on the revocation until April 5, 2018, or sooner, as required and provided in the Stipulated Settlement Decision and Order approved by the Commission on April 6, 2017.
- E. Oceana Cardroom may not operate as a gambling establishment without prior approval by the Commission.

The aforementioned conditions were updated for applicable lettering upon Commission approval.

Commissioner LaBrie stated that she is in favor of an evidentiary hearing to assess all of the information. Commissioner Hammond commented that she was very disappointed to hear of the issues that have occurred during the extension period, the Commission attempts to afford people the opportunity to do the right thing, however at this point she saw no other alternative to an evidentiary hearing. Commissioner To expressed he shared the same concern as Commissioner Hammond and that he too was very disappointed with the situation.

Bureau Assistant Director Morrow confirmed the Bureau has received purchase agreements, for a buyer to purchase the cardroom, however the Bureau has not received applications from the buyers.

Chief Counsel Vlaanderen stated the hearings are presently being scheduled approximately 150 days out. Chief Counsel Vlaanderen confirmed the scope would be limited to what the Commission wants it to be, but proffered a new hearing would

be focused on what has happened between the last hearing to current. However, any factors (evidentiary facts) established in the last Commission hearing, could certainly be factors considered in the new hearing as well.

#### Action:

- A. Terry Vargas must request a letter from the Bureau confirming that the Bureau has received all documents required to be provided to it by Ms. Vargas' 2014 license conditions and stating which documents, if any, have not been provided. Ms. Vargas must provide any outstanding documents to the Bureau within 60 days of receipt of the Bureau's letter. The 60 day period may be extended if the Bureau authorizes an extension in writing.
- B. Ms. Vargas must retain a Bureau approved gambling consultant for a period of at least one year. Ms. Vargas must request Bureau approval of the consultant within 90 days of this order and officially retain said consultant within 90 days of receipt of Bureau approval.
- C. On a monthly basis for a minimum of twelve months, the Bureau approved gambling consultant retained by Ms. Vargas must provide the Bureau with a report verifying that he/she is meeting at least once a month with Ms. Vargas and that Poker Flats Casino is in compliance with the Gambling Control Act and its current licensing conditions.
- D. On a quarterly basis, starting with the quarter ending March 31, 2017, Ms. Vargas shall submit to the Bureau no later than 15 days from the end of the quarter, an update to the Bureau indicating the status of all outstanding tax obligations, including, but not limited to, satisfaction of all tax obligations or documentation of a payment plan for unpaid obligations. For the purpose of this condition, quarters are defined as follows:

1st quarter: January 1-March 31 2nd quarter: April 1-June 30 3rd quarter: July 1-September 30 4th quarter: October 1-December 31

Commission Staff Attorney III Jason Pope ("Commission Counsel Pope"), for the Commission's Legal staff, provided the Commissioners with a Default Decision for Hoa T. Nguyen and provided a brief timeline in the matter of the application for approval of a renewal of gambling establishment Key Employee License for Hoa T. Nguyen.

Commission Attorney Pope provided a procedural history regarding the matter. Specifically, in 2011, Hoa T. Nguyen submitted an application for renewal of his Key Employee License. After submission, Mr. Nguyen's application was referred to an APA evidentiary hearing based on Mr. Nguyen's request. Due to related issues, a criminal matter and an administrative matter, the hearing never progressed. In February 2017, the Commissioners retracted Mr. Nguyen's application from an APA Hearing and referred to a GCA hearing. At the same time, the Commission sent out an evidentiary referral letter which received no response. Soon thereafter, Tracy Buck-Walsh sent out a letter indicating that Mr. Nguyen retracted his request for an evidentiary hearing and waived his right to a hearing. The Commission sent out another hearing notice for this meeting and again, no response was received.

Mr. Sharp confirmed the motion for reconsideration was very limited, just to extend the time to allow Mr. Baldaramos and Mr. Goldstein of Gold Gaming Consultants, Inc. to work out a finality for the sale transaction that occurred four years ago. Mr. Sharp confirmed that 90 days seemed sufficient to allow that to occur. Mr. Sharp indicated the parties are discussing a new arrangement to bring it to finality within the next 90 days. Commissioner LaBrie asked what happens if the transaction cannot be completed in 90 days. Mr. Sharp responded that he may be back before the Commission or the decision may just go into effect, but the entire purpose of the request for reconsideration is to allow for finality of the transaction. Mr. Sharp confirmed the parties are in active talks to bring the matter to conclusion. Chief

Counsel Vlaanderen stated that if the Commission granted reconsideration, the Commission's decision will be final on the date the decision is issued. The effective date cannot be extended to a future date, and there is no provision to extend beyond the date the decision is issued. Further, there is no option to reconsider a reconsideration. The only possible remedy would be a writ. Chairman Evans commented that in light of all of the information, it would be wise to think about all of the information that the Commission has received and take no action today. Mr. Sharp stated that his client is just requesting consistency, as in the past, the Commission has afforded other parties the opportunity to wind up their business and they are simply requesting from the Commission the 90 days in which to do so. Chairman Evans responded that he could not guarantee 90 days, however he needed additional time to consider. Commissioner Hammond commented that she strongly suggested that the parties achieve finality. Commissioner To commented he agreed with the Chairman and needed additional time to review the matter as well.
