MINUTES OF SEPTEMBER 21, 2017 COMMISSION MEETING

OPEN SESSION

1. Call to Order and Pledge of Allegiance.

Chairman Evans called the meeting to order at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken with Chairman Jim Evans and Commissioner Lauren Hammond, Commissioner Paula LaBrie, and Commissioner Trang To present.

3. Consideration of A) Rescission of APA Evidentiary Hearing Referral; and B) State Gambling License Renewal Application; (Pursuant to Business and Professions Code sections 19824 (b), 19850, 19851, and 19852; CCR, Title 4, sections 12017(c), 12035(b)(4), 12054, and 12342):

Chairman Evans confirmed that this item only included Haig Kelegian, Sr., and George Sarantos and that they both are both former shareholders.

Upon motion of Commissioner LaBrie, seconded by Commissioner Hammond, and unanimously carried in a vote by roll call with Chairman Evans, Commissioner Hammond, Commissioner LaBrie, and Commissioner To voting yes; the Commission approved to rescind the referral of Haig Kelegian, Sr. and George Sarantos' 2015 renewal license applications from the evidentiary hearing process, currently referred to as an APA hearing.

Commissioner Hammond asked Dana Messina if he was content with the results from the proceedings over the last four years. Mr. Messina stated that it has not been a pleasant process, but is resolved there seems to be reaching conclusion.

Chairman Evans asked the Bureau of Gambling Control (Bureau) why the Bureau asked for the Commission to rescind the hearing referral. Assistant Director Yolanda Morrow (Assistant Director Morrow) responded that they asked for the hearing recession because the bankruptcy was resolved. The Chairman noted the New York court case that involved Mr. Kirkland and Mr. Messina with its negative implications, and asked what precisely was the Bureau recommending. Assistant Director Morrow responded that it did not believe an evidentiary hearing was warranted to address the concerns that arose from the New York decision and in the future, the Bureau could recommend conditions to address the concerns that may stem from the New York decision.

Commissioner To asked if any violations of the law occurred throughout the process. Deputy Attorney General (DAG) for the Indian and Gaming Law Section (IGLS), Bill Williams, confirmed for Commissioner To that there were no criminal allegations but contained what the Bureau describes as "sharp business practices". Mr. Williams noted the language of the Bureau report came out of the New York decision which has been vacated, but not to say did not happen. Mr. Williams commented that IGLS believes that this matter can be resolved with input of conditions on the license.

Chairman Evans asked Mr. Williams if he could recall an instance wherein the Commission had exercised its discretion for a finding for licensure based on "sharp business practices". Mr. Williams responded that in his approximate ten years at IGLS, he could not recall a time, but that did not preclude the Commission from exercising their discretion. Commissioner To commented that there were complicated transactions and strong language in the New York case, but given the fact that the Commission approved the prior transactions, the Bureau did not recommend denial, and the parties have settled their financial dispute, his inclination was to move on.

Commissioner LaBrie noted that after the bankruptcy settlement, the New York court dismissed the action with prejudice, and asked Mr. Williams if there were any circumstances that would cause this case to be reopened. Mr. Williams qualified his answer in responding that he was not involved in that case, but he was highly doubtful it could be reopened, and again noted the fact that the case was vacated did not mean the acts didn't occur, simply that it could not be relied upon which would require findings on the same issues previously heard in the New York courts and arbitration; which could certainly be performed.

Chairman Evans asked Mr. Kirkland to detail any remaining legal entanglements related to Mr. Sarantos and Elaine Long. Mr. Kirkland stated that the litigation with Elaine Long and Mr. Sarantos is completely resolved but there is still ongoing litigation against Clovis 500 and the Sarantos family. Mr. Kirkland stated that it was his contention at Club One Casino that the expansion and relocation of Clovis 500 in 2012 was done illegally without proper disclosures which led to serious financial distress to Club One Casino, Inc., which was a primary factor in their bankruptcy filed, and cost the city \$1.5 million in lost tax revenue. Mr. Kirkland stated that a RICO civil suit in federal court to address these issues which is currently pending and in the discovery stage.

Commissioner Hammond asked Dana Messina to has attest to his suitability for licensure. Mr. Messina stated that the financial situation was greatly simplified, and the New York decision was vacated. Mr. Messina elaborated on the rarity of a court vacating its own decision. Further, that he asserted the litigation stemmed from that they perceived as a wrong wherein they stood up for themselves. The arbitrator ruled against them, the New York court also ruled against them, however later set aside that decision. Mr. Messina asserted that the Bureau, Commission, local municipality, and their employees have never asserted to this Commission anything that would debase or denounce their character. The only individuals may be the Clovis 500 Club or Sarantos family. Mr. Torngren approached the podium and asked Mr. Messina to refrain from discussing specific allegations against Clovis 500 since there is a pending case and a settlement proposal before the Commission. Chief Counsel Vlaanderen noted that the Commissioners did not discuss the accusation or settlement themselves.

Mr. Kirkland added that for the past eight to ten years he has dealt with this matter. During this time he has tried to be very candid and straightforward and responsive to staff questions. Mr. Kirkland stated that he believed that the language in the New York decision was very disturbing to him and notated the factual inaccuracies in

depth to arrive at that ruling such as mixed up testimony. He stated they were certainly going to appeal it, based on the inconsistencies within the facts and the law. The judge ultimately vacated the ruling in its entirety. He stated he felt very comfortable coming before the Commission with his own integrity and things he has done before the Commission and regulators. He is not happy with the decisions, however he does not believe that that is at all reflective of the way they run the cardroom, or acted within this industry. He mentioned that the would however continue to pursue the current litigation.

Upon request by Chairman Evans, the Bureau indicated that they may be able to arrive at appropriate conditions for agenda item 4.B today if it could be tabled for a bit. Chief Counsel Vlaanderen noted that the Commission's legal team has concluded that the interim renewal license would continue notwithstanding a rescission of the hearing referral. Chief Counsel concluded the Commission could legally take action on the application at a later date if the hearing was rescinded today, but it is his preference that the Commission act on the license the same day it was to rescind the hearing referral. The Bureau and Mr. Williams expressed a desire for taking more time to draft conditions.

Commissioner Hammond moved to rescind the evidentiary hearing referral of the 2015 and 2017 applications for Club One Casino, Inc., Dana Messina, and Kyle Kirkland and to allow time to draft conditions. Commissioner To seconded the motion. Chief Counsel reminded the Commission that the preference was to wait and act on the rescission request at the same time and suggested taking no action. Commissioners Hammond and To withdrew their motion and second.
