Commissioner To inquired regarding the costs associated with advertising, and asked Designated Agent Jarhett Blonien for his perspective.

Mr. Blonien responded by stating that since Lucky Chances Casino, a 60-table cardroom, is the largest cardroom in Northern California, the amount expended for advertising is a small percentage in relation to the size and location of the cardroom. Further, Mr. Blonien added that advertising fees around this location are extremely high.

Mr. McWhorter noted his position regarding the new proposed conditions and referenced correspondence sent to the Commission regarding this matter.

#### Action:

- 3. Ruell Medina and Rommell Medina, licensed as shareholders in Lucky Chances, Inc. shall each be individually responsible for ensuring that all conditions placed on the Lucky Chances license are fully complied with, including but not limited to duties placed upon the General Manager.
- 4. If Rene Medina is observed at any time by any employee entering, or being present in, or in any way patronizing any areas on Lucky Chances's property, the General Manager or manager in charge shall within 30 minutes telephone (1) the California Gambling Control Commission (Commission), and (2) the Department of Justice, Bureau of Gambling Control (Bureau). The call to the Commission shall be made to the Executive Director at (916) 263-0700. The call to the Bureau shall be made to the Bureau Chief at (916) 227-2377.
- 5. Any communication between Rene Medina and any shareholder or employee of Lucky Chances concerning the operation of the Lucky Chances cardroom business shall be disclosed to the Executive Director and the Bureau Chief within one business day of the of the communication. This disclosures requirement applies to both oral and written communications. This disclosure must be made in writing. The General Manager shall maintain records documenting each disclosure for four years following the disclosure.

Mr. Parrinello stated that he is working with the Bureau and has several possible candidates for independent manager replacements if Mr. Bowling is referred to an evidentiary hearing. Mr. Parrinello provided a brief history of Mr. Bowling's employment and requested the Commission approve Mr. Bowling's Initial Key Employee License.

Mr. Bowling provided a chronology of his 45-year career in the gaming industry. Mr. Bowling admitted that when he was asked about a civil court case which occurred ten years ago, he did not answer some of the questions correctly. Mr. Bowling stated he was surprised his license was recommended to be referred to an evidentiary hearing due to these inaccuracies. In conclusion, Mr. Bowling reiterated that he answered the questions to the best of his knowledge with no intention to deceive.
