**MINUTES OF JULY 26, 2018  
COMMISSION MEETING**

**OPEN SESSION**

1. Call to Order and Pledge of Allegiance.

Chairman Evans called the meeting to order at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken with Chairman Jim Evans, Commissioner Paula LaBrie, and Commissioner Trang To present.

Commissioner LaBrie thanked staff for their completion of the report.

Commissioner To made a motion to approve the item with the proposed conditions.

Assistant Director Morrow provided additional information that the Problem Gambling fees, which were due to the Bureau by March 1, 2018, are still outstanding. Assistant Director Morrow noted that in light of the additional information, the Commission may want to consider placing a condition on the State Gambling License to address the issue. Assistant Director Morrow added that the Bureau has not received a purchase agreement for the cardroom.

Commissioner To withdrew his initial motion and made a new motion to approve the extension of the Renewal License with conditions, adding the condition proposed by Assistant Director Morrow.

Upon motion of Commissioner To, seconded by Commissioner LaBrie, and unanimously carried in a vote by roll call with Chairman Evans, Commissioner LaBrie, and Commissioner To voting yes; the Commission approved to extend the Renewal License through January 25, 2019, with the conditions noted below:

1. *Mr. Whiteley's State Gambling License shall be immediately and automatically revoked with a stay on the revocation until January 25, 2019, or sooner, as required and provided in the Stipulated Settlement Decision and Order approved by the Commission on January 25, 2018.*
2. *All conditions and stipulations in the Stipulated Settlement and Decision must be complied with during the duration of this State Gambling License extension.*
3. *Beginning August 1, 2018, and every 30 days thereafter, Mike's Card Casino must provide to the Commission, with a copy to the Bureau of Gambling Control, a report that demonstrates compliance with the adequate financing requirements.*
4. *By August 26, 2018, Mr. Whiteley must submit to the Bureau of Gambling Control proof of his payment in full to the Office of Problem Gambling, which was due March 31, 2018.*
