COMMISSION MEETING**

OPEN SESSION

Chairman Evans called the meeting to order at 10:00 a.m., and asked everyone to stand for the Pledge of Allegiance.

Commissioner LaBrie questioned an issue regarding a possible grand theft.

Mr. Sharp stated that when the incident stemming from a call for service was brought to the cardrooms attention, the cardroom made a diligent inquiry into the matter. The Cardroom could find no record of such report in the cardrooms record. Mr. Sharp further stated that in the event that the cardroom becomes aware of an incident similar to that which was reported, the cardroom would take appropriate action.

Assistant Morrow stated that the Bureau did not receive an incident report and did not conduct an investigation as to the incident as an incident report a requisite to start an investigation for a matter such as this.

Commissioners Lacy briefly discussed his concerns regarding marketing agreements and the current status of the regulatory process. Mr. Sharp indicated he is aware of the concerns and those noted for other cardrooms. Chairman Evans concurred with Commissioner Lacy.

Assistant Director Morrow confirmed that Robert Thomson only submitted an application for the LLC and not for himself.

Ms. Nash asked if it would be possible for the Commission to grant an extension for Mr. Thomson to submit an application.

Ms. Nash further stated that she was concerned in the time it has taken for the Bureau to review the application from Blue Lake Rancheria as the buyers of T&T Gaming, LLC.

Ms. Morrow responded that an extension is an option for the Commission should they wish to extend the license to allow time for Mr. Thomson to submit his application. In addition, the Bureau has on three occasions reached out to the representatives of Blue Lake to inquire if they intended to move forward with the application, and the Bureau has not heard back as of date.

Ms. Nash responded that was news to her and to her knowledge Blue Lake was interested in pursuing the applications. She had heard from their attorney recently affirming so.

Mr. Ramos stated that the tribe intends to sell and assign their rights to seek the license.

Chairman Evans stated that there is not necessarily a harm to the public as the cardroom is not open and would be inclined to extend 180 days with provisions that the Cardroom cannot operate.

Chairman Evans asked if Ms. Nash agreed to the condition to be placed on the Renewal License.

Ms. Nash confirmed that she did.

Todd Vlaanderen Chief Counsel, Gambling Control Commission, in person

Commissioner LaBrie discussed that Mr. De Leon has worked in the industry for 28 years and stated that she did not have a problem with his licensure as many people get the terms "termination" and "laid off" confused.

Commissioner Lacy expressed concern as he has his written information as to what happened and nothing else to prove that he was laid off.

Commissioner To provided his concerns regarding his termination disclosure.

Commissioner Lacy stated that he read Mr. De Leon's letter and appreciated his candor; however, wanted to know if Mr. De Leon has any documentation to support his statements. Mr. De Leon stated that he was terminated as he was falsely accused of sexual harassment.

Chairman Evans confirmed he was not eligible for rehire and if the matter is referred to a GCA hearing, is there additional information that the Tribal Gaming Agency (TGA) may be willing to provide. Assistant Director Morrow indicated that she would inquire.

Chief Counsel Vlaanderen indicated that if the matter was referred to a GCA hearing, Mr. De Leon may also be able to provide witnesses that may corroborate his statements.

Commissioner To asked at the time of termination, what did the employer provide him as the reason for termination. Mr. De Leon stated that he was provided termination paperwork that he signed but he was not provided a copy. Mr. De Leon confirmed that the paperwork he signed stated he was terminated. Mr. De Leon stated he was confused in the process with what wording to use in the termination.

Commissioner LaBrie stated that she does have concern with the reason for the termination and maybe the Commission needs to hear more about the matter.

Commissioner LaBrie asked if there was a way the Bureau could reach out to the TGA again and ask if they could provide additional information.

Assistant Director Morrow stated that the Bureau had reached out previously and could reach out for additional information again.

Chief Counsel Vlaanderen discussed that Commission staff was reluctant to recommend the matter be referred to a GCA hearing if the sole basis is to litigate a sexual harassment claim.

Chief Counsel Vlaanderen discussed one thing that wasn't apparent in the information is whether Mr. De Leon applied for and obtained unemployment benefits as it may be an indication of whether he knew if he was laid off as opposed to terminated. Mr. De Leon stated he could not recall if he applied for unemployment benefits.

Assistant Director Morrow stated that the Bureau's background reflects that following the termination the applicant was supported by a family member.

Commissioner Lacy expressed that both incidents appear concerning and the second incident resulted in an actual conviction and believes the matter may be most appropriately heard in a GCA evidentiary hearing forum.

Commissioner LaBrie also expressed concern regarding the two incidents. Commissioner LaBrie asked the applicant what she meant by she failed to report her earnings in a timely matter. Ms. Grant stated that she is supposed to report within a month however she reported it within three months. Ms. Grant stated that ordinarily it is deducted from the benefits and she is not certain why it was not. Ms. Grant

further explained that her criminal conviction was expunged and dismissed under criminal code 1203.4.

Assistant Director Morrow responded no.

Chairman Evans asked had anybody at Metis assisted Mr. Deng on filling out the application in his own language of Cantonese.

Mr. Deng answered no through his interpreter.

Chairman Evans stated that there appeared to be a clear language barrier and he can understand the context behind Mr. Deng's application.

Chairman Evans stated that he would support Mr. Deng's application; however, he wants Mr. Deng to ensure that he seeks the assistance he needs when he does not understand anything on the application going forward.

Mr. Sharp on behalf of Metis stated that there are many people at Metis that speak several languages including Cantonese to help employees whenever they need it.

It was discussed that outreach to employees may be beneficial so that all employees are aware of the policy.

This disclosures requirement applies to both oral and written communications. This disclosure must be made in writing. The owners shall maintain records documenting each disclosure for four years following the disclosure.
