MINUTES OF THE MAY 14, 2020 COMMISSION MEETING

Pursuant to Executive Orders N-25-20 and N-29-20 regarding the COVID-19 virus, the meeting was held by tele/videoconference and there was no location open to the public.

OPEN SESSION

1. Call to Order.

Chairman Evans called the meeting to order at 10:00 a.m.

2. Roll Call of Commissioners was taken with Chairman Jim Evans, Commissioner Paula LaBrie, Commissioner Gareth Lacy, and Commissioner Trang To present.

Prior to the start of the meeting, Chairman Evans stated that Executive Director Stacey Luna Baxter had some announcements to make. There is a new executive staff member that is going to take part in today's meeting, as well as, acknowledging the outgoing.

Executive Director Stacey Luna Baxter announced that for the past three years, Deputy Director Adrianna Alcala-Beshara has exceeded all expectations and managed to raise an already high bar within the Licensing Division. Late last year, Adrianna approached Executive Director Stacey Luna Baxter expressing that she wanted a change and luckily the Commission had a vacancy occur within the Legislative and Regulatory Affairs Division and Adrianna expressed a strong desire to continue her past work in the area of legislation. As much, and as frequently, as Executive Director Stacey Luna Baxter tried to convince her otherwise, Adrianna competed against a very strong candidate pool and was selected as the new Deputy Director of Legislative and Regulatory Affairs Division in January 2020. Since then, she has been doing a phenomenal job working both desks as the Deputy Director of Legislative and Regulatory Affairs, as well as, the Deputy Director of the Licensing Division.

Executive Director Stacey Luna Baxter welcomed Dolores Olivarez, who was hired as the new Deputy Director of the Licensing Division as of April 6, 2020, right in the middle of COVID-19. However, despite all of the challenges presented by COVID-19, Adrianna and Dolores undertook a very rigorous training since day one. Dolores came to the Commission from the California Prison Industry Authority where she was responsible for the oversight of all operational activities for the Healthcare Facilities Maintenance Program, which included oversight over 35 institutions. Dolores has hit the ground running and the Commission is pleased to have her a part of the Commission team.

In closing, Executive Director Stacey Luna Baxter thanked Adrianna for all that she has brought to the Licensing Division, as well as, the Commission.

Chairman Evans echoed Executive Director Stacey Luna Baxter's comments.

In addition, Executive Director Stacey Luna Baxter explained ZOOM participation instructions.

Chairman Evans requested confirmation from Mr. Combs whether he understood and would comply with the proposed amended condition.

Mr. Combs confirmed his understanding, and assent to the condition.

Commissioner To inquired as to why Mr. Combs had not completed his work project with the Sherriff's Department.

Mr. Combs stated that he had a medical incident and due to the injury was unable to obtain a work release. Additionally, due to COVID-19, the interview has been pushed out but he should have an update within 12 days.

Commissioner Lacy inquired if Mr. Schreiner was representing Mr. Do, and if so, what is his relationship with Mr. Ryan Kroll who was listed as the attorney.

Mr. Schreiner stated he is representing Mr. Do and Pacific United Service. Mr. Schreiner has substituted in as counsel for both applicants and has been designated as the agent for purposes of dealing with the Bureau.

It was concluded that Mr. Ryan Kroll is no longer involved.

Executive Director Stacey Luna Baxter requested that while Mr. Schreiner is on the line if he would acknowledge acceptance of the 120-day toll so that the Commission does not exceed its timeframe to act on the application.

Chairman Evans requested confirmation from Mr. Schreiner on behalf of his clients, whether he understood and would comply with a 120-day toll.

Mr. Schreiner, on behalf of his clients, confirmed his understanding, and assent to the 120-day toll.

Chairman Evans approved to table the matter at this time per request of the applicant and 120-day toll.

Commissioner LaBrie commented on the issue surrounding the litigation and timing of the letters of warning. However, upon reviewing the Bureau's responses it appeared as though matters were on the right track and will await updates during the next renewal period.

Commissioner Lacy commented that Option Two is appropriate.

Commissioner LaBrie requested to clarify if there would be two different types of licensures, one would be as a shareholder, and the other as community property.

Executive Director Stacey Luna Baxter stated Commissioner LaBrie is correct.

Chairman Evans requested confirmation from Mr. Moreno, whether he understood and would comply with the condition.

Mr. Moreno confirmed his understanding, and assent to the condition.

Assistant Director Morrow clarified in regards to the community property interest under the Third Party Provider license type there is no license category for community property interest holder. The only way that a spouse can come in for licensure is as an owner, so that would be the only option.

Staff Counsel III Jason Pope stated this item is regarding the reconsideration request regarding the Commission Second Amended Decision and Order concerning Callaye Jo Strauss, an applicant for Key Employee License. The matter has a long history, which is more fully documented in the record provided to the Commissioners.

This request was considered at a prior meeting, but was tabled until today. The Request for Reconsideration would be taken up into two parts. First, the Commissioners must decide whether to grant reconsideration and this would be done in Open Session and you would have to determine whether there's good cause for that reconsideration request. Second, if the Commissioners grant reconsideration, then the Commissioners would go into Closed Session to determine whether you would want to issue an amended decision or alternatively affirm the prior decision that you would have issued.

Commissioner Lacy stated that he has abstained in voting on this matter because of the regulations stating only those who have heard the evidence can vote in this matter which occurred before joining the Commission

Commissioner To stated that he is satisfied with the information received and discussions conducted. No further comment or question.

Commissioner LaBrie would like to grant the request to reopen deliberation, but not look at additional evidence.

Commission To responded with a no to the reconsideration. However, agreed to discussing in closed session.

Chairman Evans stated that he would go along with his colleagues and grant the reconsideration and discussion in Closed Session. Chairman Evans stated he is not committing to the matter and principal of what the issue is and wanted to make that abundantly clear.

Mr. Pope stated that when the Commission, in the absence of other cause such as evidence that could have been presented, the Commissioners in their discretion may reopen the case and grant reconsideration when making a finding of good cause, and good cause is not defined. In addition, Mr. Pope stated that there is no standard in the Commission's regulation as to what that means and this is not precedential, unless a made precedential decision, therefore each matter would be factually dependent.

A motion was made to grant Reconsideration from Commissioner LaBrie and a Second from Commissioner To.

Danielle Guard specified she would like to make a statement as follows:

Ms. Guard stated that this case is an aberration in the Commission's record and I really ask that the Commission reconsider their order in this case.

Mrs. Guard continued to make the following statements: The case deserves a reconsideration for the Commission's track record as well as Mrs. Strauss. There's no reason to believe that Mrs. Strauss is a danger to others, as the Bureau initially recommended this application.

Mrs. Strauss has no criminal convictions. She has a nearly 20-year record of being a valued employee in gaming and the court in this matter has pointed out the conclusions that were made in facts in this case, we're not supported by the evidence and unfortunately for Mrs. Strauss her Council did not point these errors out at the hearing.

Mrs. Strauss deserves a chance to continue working. The fault of her attorneys then and now, are not hers. She's had years to ruminate and reflect over the situation and I can confidently represent to you that she's reflected and learned from all of it.

I'm here today, again, asking for you to reconsider this matter even if the reconsideration is only to deny or key employee license, but to allow her to continue to have the opportunity to continue working in the industry she's worked in her whole life.

As I said in my letter to the Commission the world's really changed since we were here on March 11. Mrs. Strauss was not being able to continue to work in gaming turns her into a world with record high unemployment and a black mark on her record. That's a much tougher punishment than for her error then would have existed with record low unemployment.

We're seeking your compassion and forgiveness, as well as wanting to provide the Commission with the opportunity to rectify a decision that's not in line with the reasoning of other decisions.
