

WHY DOES THE COMMISSION CONSIDER DEBT A CONCERN?

While debt does not necessarily mean an applicant is not suitable for licensure, a large amount of delinquent debt can be an indicator that an applicant may not be financially responsible. Concern exists that if an applicant does not demonstrate financial integrity and responsibility in their personal affairs, the same could carry over to their professional affairs as well. As gambling establishments generally conduct business wherein there is a frequent

exchange of cash, chips, and other easily-convertible forms of currency, applicants' finances are reviewed very closely by the Bureau of Gambling Control and the Commission.

Another reason the Commission conditions debt is to minimize risk to the employer and the public. An employee with substantial debt could potentially pose a threat of theft or other occupational misconduct.

Because of the concerns debt may raise, the Commission may place conditions on an applicant's license requiring them to show proof of ongoing efforts to satisfy their delinquent debts.

Typically, conditions require an applicant to provide the Bureau of Gambling Control with proof of ongoing payments to satisfy their outstanding debt every 90 or 180 days. When an applicant's renewal application is being considered, failure to comply with the conditions during the initial licensure period may result in the denial of an applicant's renewal license. For these reasons, if you have a condition to provide updates to the Bureau of Gambling Control, it is important to provide them and keep a copy of your correspondence for your records. BEEN FIRED BEFORE? PLEASE TELL US!

Far too often at Commission licensing hearings, the Commissioners consider an applicant who hid the fact that they were terminated from a previous place of employment. Sometimes applicants resort to euphemisms like "let go" or "separated" instead of clearly stating that their employment was terminated. Often, when the Commissioners ask the applicant why they were not forthcoming



regarding their employment history, the applicant will state that they were afraid their license would be denied due to their derogatory employment history.

The Commission would like to remind applicants that there is no provision in the Gambling Control Act that would require the mandatory denial of a license due to being fired from a job. While the circumstances regarding the termination could form a basis for denial, the Commission has not denied a license based solely on the termination itself.

However, supplying untrue or misleading information to the Bureau or the Commission *is* cause for mandatory denial of an application. So in these cases, an applicant can open themselves to a mandatory denial while trying to cover up something that may not form a basis for denial at all. As they say, the cover-up is almost always worse than the crime.

PUBLIC COMMENT FOR PROPOSED AMENDMENTS TO HEARING PROCEDURE REGULATIONS NOW OPEN

The Commission has begun the rulemaking process to amend existing regulations related to Hearing Procedures. The Commission's hearing procedures define the processes used for approving, conditioning, and denying an application for licensure or other approval.

This proposed action has been drafted to supplement the current process to allow applicants to request to receive notices from the Commission via email; to create a process through which a new interim renewal license can be obtained; to allow for offsite livestreaming appearances for some parties or witnesses; and to create a clearer process for considering default decisions.

The Commission provided notice of the proposed regulatory action on December 14, 2018 to start the 45-day public comment period, which will close on February 8, 2019. A copy of the Notice of Proposed Regulatory Action, Initial Statement of Reasons, and Proposed Text can be found on the Commission's website under the Regulations tab (Proposed Regulations).

OFFICE OF PROBLEM GAMBLING PRESENTS ITS ANNUAL TRAINING SUMMIT IN SACRAMENTO ON MARCH 4-5

The California Department of Public Health (CDPH), Office of Problem Gambling (OPG) is pleased to announce its annual training summit on March 4-5th, 2019, at the <u>Hilton Arden West</u> in Sacramento. The training summit promotes National Problem Gambling Awareness Month and provides workshops to 200 treatment providers, the recovery community, industry representatives, community leaders, government agencies, and law enforcement. The summit is open to the public.

The theme of this year's summit is "10 Years of CalGETS: A Retrospective Look and Bridge to the Future" celebrating 10 years of no-cost problem gambling treatment to Californians. Highlights include a historical and current overview of the overarching mission, vision, and accomplishments of the CalGETS program, provided by Dr. Richard Rosenthal and Dr. Timothy Fong of the UCLA Gambling Studies Program, and CDPH Center for Healthy Communities Assistant Deputy Director Terri Sue Canale-Dalman.

Additional keynote speakers include Dr. David Ledgerwood, who is a licensed clinical psychologist and recognized expert in the study of pathological gambling disorders and will present on "Gambling Disorder and Trauma," and Brett Abarbanel, Director of Research at the UNLV International Gaming Institute, will deliver her keynote on "Online Gambling and Sports Betting."

The training summit offers licensed health professionals a chance to earn free continuing education units, and provides multiple networking opportunities during a meet-and-greet reception following the March 4 session.


