#### **ENSURE YOUR TPPPS CONTRACT COMPLIES WITH OUTDOOR GAMING**

COVID-19 has greatly impacted the way that cardrooms and third-party providers of proposition player services (TPPPS) operate. Namely, outdoor operations are permissible for most cardrooms if they comply with <u>guidelines</u> issued by the California Department of Public Health and local jurisdictions.

Cardrooms that choose to conduct outdoor operations should review their Bureau-approved TPPPS contracts to ensure that outdoor operations have not resulted in any changes to the terms of the contract. Specifically, any changes to the financial arrangements between the parties, and/or changes to the services and facilities offered by the cardroom to the TPPPS provider, will require submission of an amended contract to the Bureau for approval.

The TPPPS contract must contain a detailed description of the location and applicable security measures that will be used by the TPPPS provider for the storage of currency, chips, or other wagering instruments (4 CCR section 12270(b)(7)). Therefore, if the TPPPS provider begins using an outdoor podium for chip storage or other adjustments are made for the storage of currency, chips, or wagering instruments, the TPPPS contract would need to be amended to reflect this new arrangement.

Additionally, any changes to the financial arrangements between the parties will require an amended TPPPS contract (4 CCR sections 12270(b)(14) and (21)). This would include, but is not limited to, agreements to reduce payments owed under the contract due to a closure or decrease in services and facilities used, or potentially an increase in fees due to the use of additional outdoor facilities. Any changes to the amount reimbursed by the TPPPS provider for equipment will also require an approved amendment to the TPPPS contract (4 CCR section 12270(b)(20)).

Guidelines for submitting a request to the Bureau to review and approve an amendment to the TPPPS contract can be found in 4 CCR section 12272(b).

## HAIL AND FAREWELL

The Commission bids a fond farewell and happy retirement to our former Chief Counsel, Todd Vlaanderen. Todd retired in May after seven years as Chief Counsel at the Commission, and 20 years total in state service. Todd's positive attitude, sharp legal mind, and willingness to offer assistance and guidance to all who asked made him an invaluable asset to the Commission.

In that spirit, please join us in congratulating our new Chief Counsel, Jason Pope! Jason has worked as staff counsel for the Commission since 2008. He has acted as Lead Attorney for several years on the administrative hearing process and tribal matters. His knowledge on a range of legal matters, and especially gaming law, will remain a benefit to the Commission and the gaming industry in California.

On April 23, the Governor's Office appointed Cathleen Galgiani to the Commission as the Governmental Experience member. Commissioner Galgiani served as a California State Senator from 2012 to 2020 and as a State Assemblymember from 2006 to 2012, and was a member of the California Legislature's LGBTQ Caucus from 2011 to 2020. She was Chief of Staff and Consultant to the University of California, Merced for Assemblymember Barbara Matthews from 2000 to 2006 and Deputy Director for Special Projects for the Office of First Lady Sharon Davis in the Office of Governor Gray Davis in 1999. She was a Field Representative for Senator Patrick Johnston from 1994 to 1998 and Campaign Staff and Volunteer Coordinator for John Garamendi for California Governor from 1991 to 1994.

On May 28, the Governor's Office appointed William Liu to the Commission as the Banking/Finance member. Commissioner Liu has been a member of the Gaming Policy Advisory Committee since 2017. He was Chief Fiscal Officer at the California Department of Technology from 2009 to 2015, Branch Chief for the California Department of Health Services from 2006 to 2009 and Audit Manager for the California Earthquake Authority from 1997 to 2006.
