

#### INTRODUCING GOVERNMENTAL EXPERIENCE COMMISSIONER CATHLEEN GALGIANI

This year, the Commission added four new Commissioners: Eric Heins, Edward Yee, Cathleen Galgiani, and William Liu. In this issue, we profile Commissioner Galgiani, and will introduce Commissioner Liu in a future issue.

#### What about the Commission attracted you to the position?

I sought this appointment to continue my public service in an area that has long been of interest, and one that I have watched evolve over time. My interest in gaming started 20 years ago, when as former Chief of Staff to then-Assemblymember Barbara Matthews, I joined her on a trip to some of the tribes that were just beginning to operate casinos within temporary structures. It was fascinating to hear how tribal leaders collaborated with local governments to improve roads, provide fire services, access water, and expand services to their tribal members. As a member of the Legislature, I had the privilege of serving on the Governmental Organization Committees in both houses where I learned about the evolving issues impacting the tribes, cardrooms, and horse racing. I am grateful to serve in a new capacity working directly with those who are seeking to work within California's controlled gaming industry.

#### What are some insights from your previous experience that will aid you in your new role?

As a former legislator, and staff member to legislators, I was responsible for resolving numerous problems that constituents had with various government agencies. While I wasn't always able to provide them with the resolution they were seeking, I always ensured they understood the process and their rights to appeal a decision. This experience informs my perspective on the Commission, and my belief that each applicant should be informed of their right to an evidentiary hearing so that they may have the opportunity to explain the circumstances surrounding information that may disqualify them for licensure. The decisions we make as a body have a tremendous impact on an individual's ability to work in the industry, and as such, this will always be at the forefront of my thought process and something I don't take lightly.

#### INTERIM OWNER LICENSES AND QUALIFYING EVENTS: WHAT TO KNOW

The Commission may issue an interim owner category license (interim license) for cardrooms and Third-Party Provider of Proposition Player Services (TPPPS) business licensees following a "qualifying event." These licenses are valid during the time the Bureau of Gambling Control (Bureau) and the Commission process and consider the regular license.

The definition of a "qualifying event," in <u>California Code of Regulations (CCR)</u>, <u>Title 4</u>, <u>section 12132</u>, requires four things: (1) an event; (2) resulting in a change in ownership, or the control of the ownership interest for non-natural persons; (3) that prevents the cardroom or TPPPS business licensee from conducting gambling operations or the provision of third-party proposition player services; (4) because the new owner does not hold a valid license.

A cardroom or TPPPS licensee must notify the Bureau and Commission within 10 days of a qualifying event, and the new owner or individual in control of the ownership interest must submit a request for an interim license. (4 CCR section 12134(a))

The death of a person in control of an ownership interest can have varying degrees of impact on the operations of a cardroom or TPPPS business licensee. For instance, the death of a shareholder may not be considered a qualifying event if there are other shareholders that are natural persons who are still able to vote their shares to direct the corporation.

However, when the death of a shareholder results in lack of control by at least one licensed natural person, the interim license regulations are likely applicable. For instance, when there is a non-natural person owner such as a corporation, partnership, or limited liability company, but there are no licensed managing members, general partners, directors, shareholders, etc. to manage the entity or vote on integral matters, then a qualifying event may have occurred even though the non-natural person owner remains licensed.

In complicated ownership structures, it may be unclear whether a natural person is in control of the entity owning the cardroom or in subsequent entities. There is no clear limitation to how far down the tiers of ownership the Commission should go to consider whether there is a natural person in control. Since there is some ambiguity as to what the regulations require as far as a qualifying event preventing continued cardroom or TPPPS business operations, the Commission can exercise discretion to apply the regulations. In this regard, it is helpful to the Commission when an applicant includes sufficient information regarding the operational challenges arising from death of a natural person affiliated with the owner entity when requesting an interim license.

When the death of a natural person in control of the ownership interest does not prevent continued operations, the owner entity remains licensed, and there is at least one other natural person in control of the ownership interest, then there is likely not a qualifying event and there is no requirement for a successor to request an interim license. In that case, the successor can apply for a temporary owner category license in conjunction with submission of the initial application rather than request an interim license.

The Gaming Policy Advisory Committee (GPAC) has seats expiring in five categories at the end of the year. The Commission is looking forward to reviewing applications from qualified candidates for representatives for the Third-Party Provider of Proposition Players Services, large cardroom, and small cardroom categories, as well as the Business/Accounting and Public Member-at-Large seats. # PUBLIC COMMENT PERIOD OPEN FOR SOUTHERN CALIFORNIA HEARINGS — AND WHY IT'S IMPORTANT TO SUBMIT COMMENTS IN A TIMELY MANNER

In August, the Commission published <u>proposed regulations</u> that establish a system for holding Gambling Control Act (GCA) administrative hearings in Southern California. These proposed regulations will improve GCA hearing attendance by Southern California residents by providing them the opportunity to be heard closer to their home.



Improving access to an applicant's rights to due process and a thorough evidentiary hearing by reducing travel burdens for these applicants should result in a decrease in the amount of withdrawn hearing requests and failures to appear, both of which result in default denial decisions.

The public comment period for these proposed regulations ends at midnight on October 5. Please submit written comment to lawsandregs@cgcc.ca.gov.

The Commission has historically gone above and beyond in conducting multiple public meetings on a majority of its regulatory packages. The Commission does this because we are truly interested in stakeholder comments and believe they often make for a stronger regulation package. As such, for all regulatory processes, I strongly encourage anyone with comments or concerns about proposed regulations to submit them to the Commission well prior to the public meetings, allowing sufficient time for staff and the Commissioners to review them.

While we are happy to take comments at any stage of the process, and enjoy the robust conversations that result from comments made during the public meetings, it is in everyone's best interest that you submit comments in advance of the Commission's public regulations meetings.

I truly believe that when comments are submitted in advance, it provides for a more efficient process that allows the Commissioners and Commission staff to thoroughly understand your concerns, and possibly alleviate those concerns or propose thoughtful amendments to address your concerns prior to the public meetings.

In addition, we often utilize the Gaming Policy Advisory Committee (GPAC) to review proposed amendments and gather feedback from the GPAC members. The GPAC meetings are another public forum where our stakeholders can submit comments and discuss the proposed regulations.

We encourage our stakeholders to participate in the regulatory process, because through your input, we are able to implement policies important to our stakeholders, the general public, and the Commission. To that end, please submit your comments at the earliest stages of the regulatory process to ensure an efficient and effective process.



## GOVERNOR NEWSOM SIGNS AB 137, PROVIDES ECONOMIC RELIEF TO GAMBLING INDUSTRY AND WORKERS IN CALIFORNIA

On July 16, Governor Gavin Newsom signed <u>AB 137</u>, which directly impacted our stakeholders in the gambling industry. The legislation amended <u>Business and Professions Code section 19821.1</u> and as a result:

- Cardroom business licensees are not required to pay any annual fees ordinarily due between January 31, 2020—July 31, 2021. The Bureau of Gambling Control (Bureau) will issue a refund for any fees already paid for this period. This fee waiver does not apply to extensions or installment agreement due dates for annual fees due prior to January 31, 2020.
- Third-party providers of proposition player services business licensees are not required to pay for any annual fees ordinarily due September 1, 2020—August 31, 2022. The Bureau will issue a refund for any fees already paid for this period. This fee waiver does not apply to extensions or installment agreement due dates for annual fees due prior to September 1, 2020.
- Licensees are not required to pay any fees or deposits associated with a renewal license or Commission-issued work permit application ordinarily due March 1, 2020—April 30, 2022. The Bureau will issue a refund for any fees already paid for this period. This fee and deposit waiver does not apply to extensions provided for fees and deposits due prior to March 1, 2020. The waiver also does not apply to initial applicants. The waiver applies to renewal applicants only.
