Mr. Harris will maintain a detailed log of every session of gambling activity by him at Casino 99, including the beginning and ending time, source of funds used, the amounts wagered, and where winnings, if any, are deposited.~~
- ~~6. Casino 99 shall bear all costs associated or incurred in connection with engaging and retaining the Consultant and the Consultant performing the responsibilities under these conditions. Casino 99 shall not have the power to terminate the Consultant without the Bureau's prior written approval.~~
