Re: Informal Public Comment Period for Draft Regulations Concerning "Transactions"

This is to inform interested parties that the California Gambling Control Commission (Commission) is holding an informal comment period on draft regulations concerning Transactions. This informal comment period will be held in advance of a forthcoming Commission Meeting in January 2026, where the Commission will consider approving commencement of the formal rulemaking process.

The Commission has held several meetings on this topic in the past. A prior draft of these regulations was last presented at the Gaming Policy Advisory Committee (GPAC) meeting on December 17, 2024. Based on the comments received at that GPAC meeting, staff have prepared an updated version of the draft text and a description.

Interested parties are invited to review and provide informal written comments on the attached draft text (version July 14, 2025). If you would like to provide informal written comments to the Commission, **please submit your written comments no later than October 1, 2025**, to ensure adequate time for review and consideration (see contact information at the end of this communication).

Please keep in mind that we have not begun the formal rulemaking process for this package. The Commission is offering this informal comment period prior to the forthcoming Commission Meeting in January 2026, which is not required. However, the Commission is attempting to provide the public with ample opportunity to comment on this regulatory package.
